The meeting began with worship at 9:15 am.

Bill Carlie read a quote from Parker Palmer from the silence.

In the absence of a clerk for Interim Business Meeting, Friends approve Bill Carlie to serve as clerk.

19FIBM-01 Friends approve Bill Carlie to serve as acting Interim Business Meeting clerk, and thus as the supervisor of SEYM staff until Winter Interim Business Meeting.

The clerk read the list of open positions from the **Nominating Committee**. Friends approved the report from the Documents in Advance.

Liz Dykes reminded Friends to speak so she can hear them.

Friends made announcements. The meeting adjourned until 1 pm for committee meetings and lunch.

The meeting reconvened with worship at 1:02 pm. Friends gathered slowly.

Bill Carlie read a quote from Robert Allenson from the silence.

The clerk reviewed the agenda. There is an addition: Crescent City report.

The clerk read the roll call of meetings. Friends introduced themselves.

Friends approved the Executive Committee action minutes from Friday night, Tenth Month 4.

19FIBM-02 SEYM Friends are grateful for the hospitality of Tampa Friends. The light-filled meeting house, the grounds on which to camp, the spaces inside and out for committees, the delicious lunch, and most of all the loving spiritual care given to us are deeply appreciated.

The **Peace and Social Concerns Committee** met this morning. They discussed follow up on the Wendy's boycott and the work of the Coalition of Immokalee Workers, as well as the Child Detention Center in Homewood, the healing project with Native American boarding schools, skype meetings with AVP facilitators, as well as other possible projects. The Towards Right Relationships project is now under the care of Friends Peace Teams.

19FIBM-03 Fall interim business meeting of SEYM recommends that Monthly Meetings in Florida contact local chapters of the Florida Rights Restoration Coalition to learn how our meetings can support the reentry and restoration of voting rights of formerly incarcerated, returning citizens, and report back to the SEYM Peace and Social Concerns Committee about their findings.

19FIBM-04 Fall Interim Business meeting directs Peace and Social Concerns Committee to work with the Administrative Secretary to collect the information from meetings about contact with the Florida Rights Restoration Coalition and have a preliminary report by Winter Interim Business meeting.

SEYM Peace and Social Concerns wants to encourage all Monthly Meetings to contact all county commissioners and request copies of all contracts with the Department of Corrections. The goal is to end the use of prison labor in Florida; this is a form of involuntary servitude. Peter Ackerman will be a contact person for this campaign. The proposed minute is returned to the committee for further development.

Peace and Social Concerns will create a packet of information to distribute. Cece talked about how a campaign is different from a single action.

Friends accept the report of Peace and Social Concerns Committee.

Peter Ackerman reported on **Crescent City**. He is aware that the seasons are changing. He has a project, the Pond Lily House, which is property he acquired, but feels he is the caretaker, the steward, not the owner. It is available to Friends and others seeking spiritual restoration. There are fruit trees and a garden. This year there have been 12 visitors. This year there has been a prayer walk around Lake Okeechobee, for the health of the Lake. He has gotten the Department of Corrections (DOC) contracts from the Putnam County Commissioners. He presented a workshop to the Commission, which was attended by officials from the DOC along with sheriffs and deputies. It didn't go well, so Plan B is moving forward. Pete has been working with Angel Duke to promote social action in Putnam County.

Susan Wade reminded Friends that if there are events happening that need to be shared with Friends and meetings throughout SEYM, let her know.

Friends thanked Peter.

The clerk called Friends' attention to the reports from AFSC representatives and the Secretary for EarthCare in the Documents in Advance. Friends accepted the reports.

Kody Hersh added to his report from the **Youth and Young Adult Coordinator** in the Documents in Advance. He asks for help promoting a program for youth at all Interim Business Meetings. A real joy this month was coordinating with Beverly Ward, Field Secretary for Earthcare, on the virtual climate strike. Friends accepted the report.

Archives Committee referred Friends to its report in Documents in Advance. Phoebe Andersen added her plea for Monthly Meetings to submit their minutes to her for the Archives. Friends accept the report.

Clara Diaz reported for **Worship and Ministry**. It is humbling that the group has such a depth of spirit and commitment. The spiritual life of SEYM is a primary concern. We are making a commitment. We will say less and do more. Friends accept the report.

The clerk introduced **Shoshana Abrams from FCNL**, speaking by phone. She spoke to Friends briefly about the Advocacy Teams program. Advocacy Teams are community base groups, building long term relationships with a member of congress and/or the congressmember's staff, lobbying on a single issue each year. Literature was available for Friends.

Chad Martin of Gainesville Friends is part of FCNL's youth advocacy group. Shawna Doran of Gainesville Friends will contact FCNL to distribute advocacy team packets to all meetings.

Phil Stone reported for Peace and Social Concerns. He presented the revised minute.

With the goal of working together with other concerned individuals and groups in Florida to abolish the use of prison labor by governmental entities, the Fall Interim Business Meeting of SEYM encourages all monthly meetings to contact their respective county commissioners and, as a first step, request copies of all county contracts with the Florida Department of Corrections.

Peace and Social Concerns Committee intends to present a report to the Winter Interim Business Meeting and requests that you forward copies of all documents obtained by November 30 to ceceyocum@aol.com. Information and a resource packet can be obtained from Peter Ackerman, 386-203-1512; petequaker@gmail.com.

Susan Taylor reported for **Committee for Ministry on Racism**. They asked the question, "How do we become an anti-racist yearly meeting?" The committee had recommendations for how Friends who identify as white can become anti-racist. The full report is attached (Attachment 1). Friends accepted the report.

Joel Cook recommended the CNN program United Shades of America.

Susan Wade recommended books Devil in the Grove and The Warmth of Other Suns.

Joel Cook gave the **Treasurer's report** for the fiscal year ending May 31, 2019. A question was asked about the loss; there was no one category that accounted for the loss. Joel and other Friends explained about the apportionment and how members and attenders were counted. Friends accepted the Treasurer's report (Attachment 2).

The clerk read the final report of the **Half Yearly Meeting committee**, updated after the Documents in Advance (Attachment 3). Registration opens October 10. Friends accept the report.

Vicki Carlie reported for **Gathering committee**. Vicki Carlie and Susan Wade will handle the registrar responsibilities in the absence of an appointed registrar. Andrea will be talking to the Life Enrichment Center and the chef about how improvements can be made. We are looking for an alternate site for 2021 and forward for yearly meeting gathering. Three committees have come forward to take some workshop slots. Friends should let the committee know what books are needed for workshops or just recommended for the bookstore. Caroline Kaufman is the bookstore coordinator. Friends accepted the report.

Youth Committee is open to more volunteers for reviewing the CAPP manual.

Mercedes Soca reported on **Havana Friends Worship Group**. The person who was trying to revitalize the group gave up, however, one of the founders of the worship group visiting Cuba met with others who are interested in getting the worship group started again. Mercedes asked for Friends to help her keep in touch with the worship group.

Committee for Ministry on Racism Report

SEYM Fall Interim Business Meeting (FIBM)
October 5, 2019

We gathered in worship, followed by introductions:

Jean Larson (Gainesville), Richard Frechette (Ft. Meyers), Dave Hilsheimer (Sarasota), Katie Green (Clearwater), Bethany Cavano (Tallahassee), Susan Taylor (Tallahassee, Co-clerk). Susan Taylor and Jean Larson were the two members of the Committee who were able to be present. They expressed gratitude for the presence of other Friends who actively attended and participated.

How do we become an anti-racist yearly meeting? We asked this question from the stated aspiration of Friends General Conference, with whom SEYM is affiliated, to become an anti-racist organization. Friends General Conference has appointed an Implementation Group for carrying through with the results of their Institutional Assessment on Systemic Racism that was completed a year ago. Susan Taylor, an SEYM representative to FGC, will report further on this after the October 24-27, 2019, annual FGC Central Committee meeting. We expressed gratitude for racism information that is being spread through the media and for the increasing number conversations and activities among Friends and others about racism. Our awareness is being raised. Sometimes it feels difficult to discern what the focus of the Committee for Ministry on Racism should be.

One of the first things those of us who identify as white can do to personally becoming aware of our implicit biases that see people of color as "other," is to have conversations with each other about our questions, fears, anxieties and experiences of the made up social construct of race in the U.S. It is important that our conversations be held in loving-kindness, encompassing all with whom we communicate. Friends and others are in various stages of awareness about personal and structural implicit biases. Answering that of God in everyone is the foundation of all communication. Open communication is the beginning of creating anti-racist lives, including an anti-racist Yearly Meeting and Religious Society of Friends. We acknowledged that we who grew up in the U.S. and identify as white cannot be non-racist but can be actively anti-racist. We looked at the difference between the terms non-racist and anti-racist, as part of our individual sharing throughout more than the first half of our meeting.

Jean Larson reported that the library in Gainesville had photographs of early African American history and one was related to lynching. In the photo, white people are picnicking while black bodies hang on trees in the background. She reported on the visit of a Friend to the Equal Justice Initiative's Peace and Justice museum in Montgomery, Alabama. Gainesville City Commission was asked in relation to the visit: "What can we do?" Some were willing to work on addressing the issue, some said that is "not in our job description." We acknowledged that for those of us who are white, the white culture feels "normal" rather than oppressive. We often don't understand where people of color are coming from. There is a clear sense of "other". We yearn for that not to be the case. We want to continue to explore that dynamic and change it. The question was asked, "How can we be an ally to people of color?" We spoke of personal experiences of adopting children of color into our nuclear families. We asked, "What can I find out about Native Americans in my own community?" There are not many Indian names of places left in Alachua county, as one example. The original names have been erased and replaced. What are experiential exercises we might develop to help us feel and appreciate the waves of history that

continue to affect people of color, including those who are neither Native American nor African American?

We spoke of Paula Palmer's, (Boulder, Colorado Monthly Meeting) ministry, "Toward Right Relationship with Native Peoples" and of our gratitude that this ministry has been moved into Friends Peace Team's North American focus. We remembered the powerful impact of the experiential exercise of that ministry at SEYM's Half Yearly Meeting and Yearly Meeting Gathering- an experience that helped us begin to have a visceral understanding of the effects of the Doctrine of Discovery and resulting colonialism. We were also grateful to hear that Kody Hersh will be leading that exercise at Gainesville Meeting later this month. We are grateful for the progress made by the "Fair Food Campaign" and encouraged Friends to boycott Wendy's as part of that Campaign, since that fast food chain has not signed on to the Campaign.

We acknowledged the continuing need for resources to help us learn. The Committee for Ministry on Racism's SEYM web page has many resources and the Committee would like Friends to contribute others that have been useful to them. The Harvard researchers' online test might be useful in helping us identify our unconscious biases, though there is heated controversy about this among scientists, especially if the test is taken just once. It is being updated. The book, "When They Call You a Terrorist:

A Black Lives Matter Memoir" (Asha Bandele and Patrisse Cullors) has been helpful to some. Also, the film, Rosewood and David Billings' book, "Deep Denial: The Persistence of White Supremacy in United States History and Life." We touched on the exception clause to the 13th amendment of the U.S. Constitution as a stimulant for mass incarceration. This is but one example of the lack of equity in treatment in the U.S. for people of color when compared to the treatment of those who identify or are identified as white. We asked Friends to continue to contact our legislators about beginning the process to remove the exception clause from the 13th amendment to the U.S. Constitution.

We reviewed the report of the Committee for Ministry on Racism in the Documents in Advance for FIBM and encouraged each other to go to the links there to learn in more detail the background for actions recommended in the report. A correction in the report is that the immigration detention center in Homestead, FL has not been closed. There are no longer children there, but staff remain. Efforts continue to be made to close it down. AFSC and others are continuing to research where the children were taken, though many were apparently reunited with their families.

The Committee has asked for 2.5 hours of workshop time at the SEYM April 2020 Gathering, with topic to be decided.

During the Executive Committee meeting 10/4/19, SEYM Clerk, Bill Carlie, gave Susan Taylor a copy of a proposal from Baltimore Yearly Meeting's Growing Diverse Leadership Committee for Baltimore Yearly Meeting's 2019 Annual Session: "Declaration by Baltimore Yearly Meeting as an Anti-Racist Faith Community." He will send an electronic copy of the statement to Susan to be considered by the Committee during their Zoom video teleconference, which will be held later in the Fall.

Treasurer Report for 2018 - 2019 Fiscal Year, Fall Interim Business Meeting 2019

Annual Report for end of Fiscal Year 2018-2019 (June 1, 2018 thru May 31, 2019)

All values are rounded to the nearest dollar.

SEYM Total Cash Flow not including Trustees

The overall cash flow of the Yearly Meeting (excluding separately reported accounts under the care of the Trustees) yielded a net loss (excluding unrealized capital gains) of \$3,950. This resulted from an SEYM total real income of \$129,111 against total expenses of \$133.061.

SEYM General Fund for Administration - Cash Flow and Budget Performance

At the end of the fiscal year, the General Fund (the operations fund for which we approved a balanced budget of \$79,535 in our 2018 Yearly Meeting sessions) showed a net income of \$8,053. This resulted from General Fund total income of \$71,172 (90% of budget) against expenses of \$63,119 (79% of budget).

Including the Youth and Young Adult Coordinator compensation the net income was \$3,803.

Budget Support Apportionments & Contributions Received

During this fiscal year, in response to the annual request for support of the approved General Fund Budget (the Apportionments), contributions received from the Monthly Meetings and Worship Groups totaled \$62,564, or 90% of the year's budgeted request of \$69,715.

Sixteen Monthly Meetings and two Worship Groups were included in the Apportionment request this fiscal year. 15 contributed between 95% and 100% of their requested amount, 1 contributed 45%, and 2 have not contributed anything.

The unrestricted individual donations received toward the Budget during this period totaled \$930, approximately 47% of the \$2,000 budgeted amount.

A Worship Group with no requested apportionment has donated \$315.

Cash Flow Results for Programs

The annual programs for this fiscal year are complete. There may, however, be some adjustments to these figures.

The Yearly Meeting Gathering and Walton Lecture had an income of \$37,180 and expenses of \$38,046, yielding a net deficit of \$866.

Half Yearly Meeting had an income of \$2,853 with expenses of \$3,147 giving a net deficit of \$295.

The Michener Lecture had an income of \$2,183 and expenses of \$1,998, yielding a net income of \$186

Programs for Youth had income of \$0 with expenses of \$1,923, yielding a net deficit of \$1,923.

The Publications program during this period had a net real income of \$22 excluding unrealized capital gains of \$331 on investments for the program.

The SEYM Field Secretary for Earthcare program during this period received \$12,825 in donations and had expenses of \$18,033, yielding a net deficit of \$5,208.

Net Worth

The Net Worth of the combined Yearly Meeting and its Trustees at the end of this period was \$565,685, a decrease of \$2,445 including \$1,669 in unrealized capital gains since the beginning of the fiscal year.
