They are also concerned with landfill issues which is a national problem but of particular concern in Broward County where the landfill is near capacity.

Phoebe Andersen reported for Archives Committee. They are planning to visit University of Florida in May to continue working. Phoebe asks all meetings to send her their minutes and newsletters electronically.

Joel Cook reported for Friends World Committee for Consultation (FWCC). He attended the Section of the Americas meeting last week along with Eduardo and Clara Diaz, and Cheryl Demers-Holton. The FWCC World Gathering will be held in South Africa in late 2024 and will have very limited attendance: only one person from each yearly meeting. Joel feels that it should be a young person. He added that there are specific funds set aside in the SEYM budget to assist SEYM Friends who wish to travel to world gatherings.

Liz Dykes reported for Friends General Conference. The Gathering of Friends will be in Monmouth, Oregon, July 2-8, in person. Early registration opens on April 3.
