# **SEYM Executive Committee (EC) Report**

### Winter Interim Business Meeting, First Month 16, 2015

The Executive Committee meeting began with open worship at 7:00 PM at Orlando meetinghouse. Joel Cook, Assistant Clerk, served as Clerk in the absence of Ann Jerome, Interim Business Meeting and Executive Committee Clerk.

The acting Clerk circulated the agenda. There were no additions.

There was no Clerk's report.

Vicki Carlie, Administrative Secretary gave the Secretary's Report, which is in Documents in Advance. She and Amy Carlie have been working on the new SEYM website and have found a host that is less expensive than the former one. Links to the developing website will be sent to EC members for comments during the process. Executive Committee was pleased with the part of the website she showed us on her iPad.

The Administrative Secretary's experience is that SEYM needs to have a publications committee to handle the many issues involved with publishing. Lively discussion followed that affirmed that need.

The Secretary was thanked by the Committee for Earthcare on the stunning website she created for the committee. The Executive Committee gave appreciation to the Administrative Secretary for her work.

Committee reports were given:

**Committee on Earthcare:** Barbara Letsch, co-clerk, reported: The report is in the Documents in Advance. Their proposed minute has been revised to include a Field Secretary.

**Worship and Ministry:** Nancy Triscritti, clerk, reported: The committee welcomes Michener Lecturer, Benigno Sanchez and his wife, Karen, who have arrived. Benigno has recently returned from Cuba and will join us for WIBM Saturday events. Diane Randall, Executive Secretary of FCNL, will be the 2016 Michener Lecturer.

**Committee for Ministry on Racism:** Ellie Caldwell, co-clerk, reported. The committee has been overwhelmed by all of the national events reflecting the depth of racism in our country. The committee hopes meetings and worship groups are attending to this endemic racism as they are led.

**Nominating Committee:** Susan Taylor, Clerk, reported. The committee's report is in the DIA. Susan reminded EC that two members of the committee, Susan Taylor and Andrea Hoskins, would be going off the committee in 2015.

The Acting Clerk reminded Friends that a Naming Committee to name members for Nominating Committee was formed at the Fall Interim Business Meeting Executive Committee meeting: Joel Cook and Peter Schmidt.

The Yearly Meeting Clerk reminded committee clerks to draft any minutes they might have for Yearly Meeting sessions and give them to her before business sessions.

Peter Crockett (St. Petersburg) brought forward his leading on working with issues around aging and his informal proposal for a new Committee on Aging. The Executive Committee was very supportive of his leading and much discussion followed. The committee recommended that he ask St. Petersburg meeting for a clearness committee to further season the idea and see what the charge for this committee might be. Peter mentioned that George Schaefer, LCSW (Licensed Clinical Social Worker), Care and Aging Coordinator for Philadelphia Yearly Meeting, would be giving a workshop at

There was discussion on updating the Yearly Meeting's Operational Handbook, Procedures and Job Descriptions. This handbook is on the SEYM website and in hard copy loose-leaf binders for ease of revising. It does not have to be approved by the Yearly Meeting. Past and current officers and clerks of committees will begin to revise the sections appropriate to them. Their revisions will go to a larger committee for further review and editing before final approval by the executive committee.

Further discussion on publications ensued. The Yearly Meeting Clerk will call Lyn Cope, who has a contract for SEYM publications, to ascertain the status of four outstanding publications and her ideas on future publications. The two mandatory publications for the Yearly Meeting are the Michener and Walton Lectures. Endowments for those lectures require that they be published. Nancy Triscritti will call Deborah Fisch, who has recovered from a life-threatening illness, to discuss the publication of her last year's Michener Lecture.

Other ideas on publication brought forward by committee members included the desire to have younger Friends on a Publications Committee, possible digitalization of old lectures and introducing newer ways of sharing information using internet technology. The latter is especially important to younger Friends. Friends suggested that it is important to review the 2013 SEYM information on communication within the Yearly Meeting dealing with short- term issues. It is also vital to consider long-term issues with publications. A Friend asked, "What is our philosophy about publications?"

The Executive Committee approved the following minute:

## **Youth Committee Report**

We have gone almost a year with no clerk. The current convener will step down at the end of this year. CAP staff and a framework for programs are in place for the Youth Program at the 2015 Yearly Meeting. "The Ties that Bind" is the overall theme. Our teen clerk, Kate Sundberg, met with QEW and Peace and Social Concerns Committees this morning to work with them on opportunities for activism and training in our youth program, specifically for the teens. We are exploring the possibility of our middle school youth using their consuming interest in technology to make a video documentary of the Yearly Meeting.

## **Earthcare Committee** Report to WIBM 2015

The Earthcare Committee reported the status of the seasoning process of the Proposed Minute for an SEYM Field Secretary for Earthcare (FSE). The committee reported that feedback from around SEYM was received. The committee labored in a subgroup to take the F/friends input and rewrite the proposed minute offered today for an SEYM Field Secretary for Earthcare (see attached proposal documents below).

We are pleased to report that \$1,000 in matching donations have been raised in a "kick-starter" funding proposal for an FSE. We request \$500 be budgeted for the Earthcare Committee from the Finance Committee to administer oversight of the FSE. Initially funding for this position would be per diem to cover expenses.

The committee answered questions asked by WIBM participants, including those on duties and oversight of this position. Separate documents on these subjects will be emailed with the proposed minute. It was made clear that we are still in the seasoning process. We will be sending out emails to all MM clerks requesting they discern with their meetings this proposal and provide the Earthcare Committee with their feedback by February 28. The committee will require adequate time to edit their input and distribute a revision of the proposed minute prior to the start of YM on April 1.

Peace & Social Concerns clerk, Warren Hoskins, read a minute of support for the proposed FSE during our report. We were very grateful for the support we have received today and for the thoughtful questions we have received.

# Archives Committee Report Winter Interim Business Meeting 2015

The Archives Committee met at the University of Florida on June 23 and 24, 2014. We filed additions to the Fort Myers, Palm Beach and Gainesville Monthly Meeting files. We sorted and filed Pro Nica information and SEYM Newsletters. Photographs were put in archival condition. We added two years of SEYM minutes to the collection. Augusta Monthly Meeting materials have been sorted, filed, and placed in their own small box.

Most of SEYM's documents are in order. Overlapping files have been examined to determine the best preserved copies of information. Duplicate and triplicate copies in worse condition have been removed. There are still unsorted boxes of SEYM documents. Documents in Advance are being collated with the corresponding minutes and then placed in separate files by year. There are still boxes of materials to be identified, sorted and filed.

The Archives Committee also met at the University of Florida on August 20 and 21, 2014. Martha Morris and I consulted the Archivist, Flo Turcotte, concerning the advisability of storing our materials on modern digital form as opposed to paper. She advised us to use digital forms, as the paper is taking up much space in the Special Collections Library. The library is able to "forward" the digitally preserved materials to the most modern form. The committee is going to have to learn how to cooperate with the library to achieve this.

In the meantime, we have some advice for everyone who sends, or preferably gives us material to archive. Everyone who has worked on SEYM minutes is lucky to have any hair left. Please date all materials, preferably with a date or number on each page, especially supporting documents and reports. Sometimes the front page is missing, or there is another copy in another file and to archive the best copy, we need to be sure the papers go together. Double -side your documents, if you can. If you need to separate things, and we would appreciate separation by year, please use plastic paper clips. Metal ruins the paper and we have to take the time to remove it. Please label all digital devices with the meeting or organization, and dates covered. Please give us just minutes and supporting documents, correspondence, committee reports, and, in the case of yearly meeting, Documents in Advance. Please do not give us bills, bank statements, invoices and the like. The treasurer's reports and Budget Committee reports that are attached to minutes are sufficient information. # **Friends Committee on National Legislation**

Policy Institute and Annual Meeting Report, November 20-23, 2014

## "Living Our Faith Through Action"

SEYM Representatives, Eileen Zingaro (Clearwater), Nancy Corindia (Sarasota), Karen Putney and Lou Putney (Tampa) attended the FCNL Annual Meeting in November of 2014. Representative Jack Bradin (Palm Beach) was unable to attend and was missed. In addition, Friend Elaine Petrella (Miami) and William Lefler (Pittsburgh/Orlando) were able to attend and join in the Florida lobby effort. Representing Friends in Florida, we met with Legislative Aides in the offices of Senator Bill Nelson and Senator Marco Rubio as well as paying individual visits to the offices of Rep. Kathy Castor, Rep. Vern Buchanan and Rep. David Jolly with our request as detailed below. Every action we took, skill we learned and message we heard focused on the ongoing theme for this annual gathering of over 200 Friends from around the country ~ "Living Our Faith Through Action". We appreciate the opportunity to serve SEYM and thank Friends for your spiritual and financial support We welcome opportunities to share more about our work and witness and Karen Putney offers several workshops for Monthly Meetings who would like a deeper understanding of our witness in Washington.

As a newly appointed SEYM Representative attending her first FCNL Annual Meeting, Nancy Corindia shares her reflection on our work:

### **Spirit Led Action**

After attending the Public Policy Institute and Annual Meeting of the Friends Committee on National Legislation (FCNL), I returned with a renewed enthusiasm for the power that each of us has to effect the direction and change in our government; and, affirmation of FCNL's tireless efforts toward Spirit led legislative action, so well recognized on Capitol Hill. It is my goal to share what I've learned and the inspiration I feel, over the next year.

This year Friends asked legislators to make open statements on the floor, by email lists, or social media to keep open a space for diplomacy and negotiations with Iran on the development of its' nuclear program. Since last year, after Iran accepted the Vienna Treaty that curbed growth of its nuclear program and allowed verification of its nuclear plants. Iran has been compliant. The terms of the Vienna Treaty established an exchange that meant a decrease in some sanctions imposed on Iran for its compliance. Now it is time to renegotiate the terms of the treaty.

The Policy Institute began with an information-building day on the situation in Iran and some of the physics of nuclear power for the use of domestic energy versus nuclear weapons. Speakers included:

- Colonel Lawrence Wilkerson was Chief of Staff under Colin Powell: He calls Iran the most stable country in the Middle East right now and not to have them at the negotiating table would be a catastrophic mistake.
- Joe Cirencione is a member of John Kerry's International Security Advisory Board and the Council of Foreign Relations: He is the CEO of the Ploughshares Fund; a public grant making foundation focused on nuclear weapons policy and conflict resolution.
- Senator Chris Murphy (CT) was presented the Edward F. Snyder Award for National Legislative Leadership in Advancing Disarmament and Building Peace. He is a leader in the Senate supporting diplomacy with Iran, working on climate change, and reducing gun violence. (Many are looking for him to earn his way to the presidency.)
- Representative Rush Holt Jr. (NJ) is 1 of 2 physicists in Congress and the only Quaker in Congress. He served on the Committee on Education and the Workforce and the Committee

on Natural Resources, where he served as the Ranking Member on the Subcommittee on Energy and Mineral Resources helping to develop a long-term strategy to decrease our nation's dependence on fossil fuels in order to protect our environment for future generations. He's retired from the House, accepting the position of president of The Academy of the Advancement of Sciences.

In the afternoon, sessions began on the "how to" and etiquette of lobbying--a whirlwind experience. One piece of motivating information came from a senior staffer from a congressional office who said that her office has regular meetings of staffers who review the letters and emails that they receive from constituents. (I was so glad to hear that those emails were really read and considered.) Last year after FCNL's lobby day, the White House asked if FCNL would send them the summary sheets of the lobby visits. This year 11 Congressional offices asked FCNL for language to use in statements encouraging diplomacy in Iran. Eighteen legislators made statements in favor of diplomacy, after the lobby day.

We hear about lobbying as part of our democratic process, but until last month when I was lobbying at conference tables in congressional offices. I never appreciated how much closer this brings Americans to representatives of the government. It sent home to me in a way that hadn't before, that "We the people " are truly responsible for what our government does. We cannot be excused from the responsibility.

The keynote speaker, Parker Palmer, did as much or more to give me patience and optimism with our democratic government as any part of the weekend. He talks about opening our hearts to hold the tension that is inherent in a democracy. A heart that is broken open is able to hold the tension and continue to make progress, where a heart that is broken apart precludes progress. He encourages us to make an effort to meet people who do not share our beliefs and listen, learn, and talk with compassion.

It was cold in Washington D.C., the schedule was punishing, and I felt like I had a full graduate level course in nuclear physics and foreign politics in 3 days. But, lobbying on the same day with 200 Quakers and like-minded citizen activists, from 43 states is very empowering. I met Friends from New England Yearly Meeting, new Friends from all over the country and sought out and met the FCNL staffer for Climate Change Legislation, as climate change is SMM's current, whole Meeting, initiative.

This time at FCNL gave me more positivism in our government than I've had since before I was old enough to vote and start to recognize the ways of the world-about 6th grade. It was a privilege and a pleasure for me to represent SMM and Southeastern Yearly Meeting at FCNL's Policy Institute and Annual Meeting this year. I truly appreciate the confidence you had in me, as well as, the financial and Spiritual support that you gave me as your representative.
