Winter Interim Business Meeting January 14, 2017 Orlando Friends Meetinghouse

Minutes

The meeting was held at the Orlando Monthly Meeting meetinghouse, Interim Business Meeting Clerk, Lisa Stewart, opened the meeting at 1pm with a period of silent worship.

Acting Assistant Clerk Cecilia Yocum read a Dan Seeger quotation, a portion of which is included here:

"We, as evangelists of each other, must have it as our first duty not to preach but to listen. We must practice an open and sensitive awareness which allows us to listen not merely to each other's theology but to what the other person is. By doing this we will begin to live in such a way that we neither crush nor dominate nor entangle our companions, but rather help them to be themselves, and bring them to fulfilling service for the benefit of the larger Society of Friends. We will aim for transparency of heart; we will never manipulate each other's consciences, or try to force other members of our Religious Society into our own scheme of things. No one will seek a procedural victory, or a formulation of faith and practice, or the advancement or postponement of a concern, which leaves someone else defeated."

Roll Call & Milestones: The clerk called the roll of meetings (see_Attachment 1 - Roll Call). Those present identified themselves and announced meeting milestones. *Orlando MM*—We commend the team of volunteers providing meals for WIBM. *Palm Beach MM*—Friend Dean Sherwin passed away. *Tallahassee MM*—Meeting Michelle Lamm as a member. She had been an associate member. Margaret Fogg, founding member of our Meeting, died Jan. 7, 2017. We are working on a minute honoring her. *Tampa MM*—Friends welcome with joy new member Chris Hugues. *Jacksonville MM*—Mike Shell has succeeded Elaine Martin as Meeting Clerk.

Announcements: Lisa Stewart recommended *The Manor: Three Centuries at a Slave Plantation on Long Island* (2013), Mac Griswold's account of Sylvester Manor on Shelter Island, NY, owned by 17th century Quaker Nathaniel Sylvester and his descendants (see www.sylvestermanor.org).

Tampa MM will host Diane Randall, Executive Secretary of FCNL, for "The World We Seek: We Can Live It," on January 22 at 4:00pm. St. Petersburg MM will host an Arthur Larrabee workshop, "Friends Decision-making and Clerking: Serving the Community with Joy and Confidence," on February 10, 7-9 pm & February 11, 9 am-4 pm. Palm Beach MM will host its Annual Retreat, "Living In Community—the beauty, the challenges, and how to survive gracefully," on February 3 evening, all day February 4, and February 5 morning. Palm Beach MM will also present a Gathering workshop on how to use Quakerism 101.

Executive Committee: Mike Shell reported. There were no numbered. WIBM accepted the committee report.

Nominating Committee: Elaine Martin reported. Bill Carlie is the nominee for Clerk of Yearly Meeting. Caroline Lanker is stepping down from Trustees: Nell Andersen is the nominee to take her place. This is the first reading of the committee nominations, pending approval at Yearly Meeting Gathering.

Worship & Ministry Committee Report: Clara Diaz reported. The 2017 Michener Lecture, "From My Measure of the Light...," is to be presented by Susan Waltz on January 14. The 2018 lecturer will be Wes Daniels on topic of Convergent Friends. Jan Dahm & Lisa Erasmus will prepare "Quotes & Queries" for YM Gathering. Friends should remind MM/WG participants that 5th Sundays are Intervisitation Sundays. January 29 and April 30 are the next two dates (see http://seymquakers.org/resources/spiritual-formation-program.)

Friends have expressed concerns about blatantly political speech during meetings for worship, especially hurtful speech and attacks. On such occasions, others Friends may stand in silence in response or may say, "The meeting needs to go back into worship." (George Fox advised that it is sinful to interrupt the silence unnecessarily.) The clerk or another may elder the political speaker in private after meeting. WIBM Friends asked for training and practice in handling such events.

Friends are encouraged to make use of SEYM's Spiritual Formation Program (http://seymquakers.org/resources/spiritual-formation-program/) and FGC's Spiritual Deepening Program (http://www.fgcquaker.org/deepen/enrichment/spiritualdeepening).

Treasurer's Report: Neil Andersen distributed and described the written report (see Attachment). Financial results for some SEYM programs were incomplete as of November's end.

The Field Secretary for Earthcare (FSE) program received \$2,700 in donations by the end of November and had \$2,799 in expenses, resulting in a net expense of \$99, with remaining assets of \$20,548 (not including the \$10,000 Trustees' fund). We expect to pay for FSE out of savings for a while, but we need to become able to match expenses at least on a quarterly basis. Meetings which made multi-year commitments to FSE should budget the same amount for future annual MM budgets, with the possibility of not having that expense if the program ends.

WIBM Friends accepted the Treasurer's report.

Half Yearly Meeting: The event did well, (see Half Yearly Meeting Report

Gathering Committee: Stephanie Preston reported. The Gathering theme will be "Climate Justice," with Peterson Toscano as Walton lecturer and retreat leader. Fees remain the same as in 2016, with children 18 and under receiving meals and registration for free. Friends should remember that the best promotion is "word of mouth." Program Coordinator Richard Frechette shared several workshop topics including parenting, Sabal Trail pipeline, Quaker response in a politically divisive climate, and "True Islam vs. Extremists."

Registration opens on February 5. Friends who desire SEYM scholarships to help cover expenses MUST coordinate with their own meeting clerks, since the usual formula is that attendee pays 1/3, the Meeting 1/3, and SEYM 1/3. The registration form will have a scholarship section.

2018 Gathering themes are under consideration and the committee welcomes input. Some possible themes: racial discrimination, mass incarceration, injustice against marginalized communities, etc.

Youth Committee: No report.

Earthcare Committee: Bill Carlie reported. In its morning meeting the committee approved two internal minutes:

- SEYM Earthcare Committee unites in understanding our relationship to earth is based in the sacred. We commit to a deeper study of the environmental issues confronting our communities, our region, and natural resources, to develop priorities for action among Friends.
- 2. The Sabal Trail Pipeline and Florida South Connection, which are being built by Florida Power and Light, Next Era, and Duke & Spectra Energy, endanger culturally significant land and also put several Florida waterways, human population and wildlife in danger. We, the Earthcare Committee of Southeastern Yearly Meeting are called to support the voices and actions of those who are protesting this pipeline.

After discussion, WIBM Friends approved an amended version of the second minute and asked that it be sent to meetings with the query, "What does this minute mean to you in terms of your own commitments?"

Gainesville MM announced a forum concerning the Sabal Trail Pipeline and appropriate responses to it on 1st Day, Feb 5th at 1 PM, with Speaker Marrillee Malwitz-Jipson of the Sierra Club and FSE Beverly Ward. All monthly meetings are invited to learn about this immanent threat to our state's water supply as it works its way south.

Meeting for Worship gathers at 11 AM, Social Hour/Potluck at Noon, and Forum at 1 PM. Those with a leading to protect our water and members of Earthcare Witness or Peace and Social Concerns committees are encouraged to attend. Print and audio visual materials will be available. Information concerning Sabal Trail and resistance activities can be found on YouTube and Sierra Club websites. Peace & Social Concerns Committee: Elaine Martin Reported (see p.7 of DIA). The committee had a retreat during the day on Friday using Douglas Gwyn's *A Sustainable Life* as a resource. They shared individual and meeting experiences with P&SC activism

and considered different models for the committee's role with SEYM. There is a call for a "skills and interests" directory to help coordinate P&SC actions.

Nine meetings have signed on as partner organizations with the Florida Coalition to Prevent Gun Violence (http://www.preventgunviolenceflorida.org/), a League of Women Voters response to the mass shootings at Orlando Pulse on June 12, 2016.

The next Alternatives to Violence Project (AVP) activity is a basic workshop at the Jacksonville Church of the Brethren. The workshop begins Friday, March 3rd at 6 pm, and runs through Sunday, March 5th.

The committee is revisiting Quaker non-violent direct action resources from the Vietnam era in order to make such training available to SEYM Friends now.

Field Secretary for Earthcare: Beverly Ward reported (see attached Field Secretary for Earthcare (FSE) Report). Beverly has visited a number of MMs and other organizations, and she appreciates the synergy which also her to bring together a number of her long-term activities as FSE. Her published report illustrates this synergy in detail. She reminds Friends that may people globally are "in recovery" from climate change challenges. How do we help them? Way is opening.

ProNica Report: Pam Haigh reported (see Year-End Report at http://pronica.org/wp-content/uploads/2016/11/Annual-Report-2016.pdf) and introduced Stateside Assistant Yarrow Reis. Donations are up a bit, yet needs for funds and volunteers have also increased. For example, a retired carpenter from upstate New York contributed three weeks of labor to make repairs to the ProNica house in Nicaragua. Basic subsistence economic issues are ProNica's primary concern.

Program Director Bambi Griffin is in Costa Rica to renew her visa. ProNica is that last NGO of its kind still operating in Nicaragua, and taxes, fees and regulations under the new government keep being changed. Local partners are frightened by the return of old political powers, so Quaker presence becomes more important to them. Los Quinchos/Las Yahoskas rehabilitation program for street children has cut back its service to boys due to low funds for food (see http://pronica.org/project/los-quinchos-las-yahoskas/).

Ministry on Racism Report: Susan Taylor reported (see attached Committee for Ministry on Racism Report). Based on feedback from meetings, the committee revised the proposed "Action Request on the Thirteenth Amendment, for Further Seasoning for Suggested Approval at SEYM Yearly Meeting Sessions, 2017" (see second draft of "End Slavery for All"). The committee also recommends support for the planned Institutional Assessment for the FGC organization itself to find structural racism within FGC and recommend steps to remove it (see attached document FGC discernment).

Katie Green will be giving a workshop at the Gathering entitled "Pink Spit." She has a background in giving workshops on racism. Some of the workshop will include participants' exposure to racism at a young age. Susan Taylor will be her elder. The committee shared information that might be helpful to include in racism workshops and is open to learning more.

Friends Committee on National Legislation (FCNL) – Karen Putnam reported, advising Friends to share the website with MM/WG participants. Read Executive Secretary Diane Randell's "This new Era" (https://www.fcnl.org/updates/this-new-era-545), her

January 20 message. Look at the staff biographies (https://www.fcnl.org/updates/staff-10). Karen urges FCNL representatives to keep their meetings informed active regarding the work.

At the FCNL annual meeting (http://tinyurl.com/FCNL2016Annual) Karen noted both discouragement and the sense of commitment: "Now we have to double down." Many of the 42 staff are young people who are very talented yet still learning to cope with the setbacks of political action. Over 200 Friends who lobbied Capitol Hill noted a shocked, subdued mood among staff of both parties.

Folks of both parties want to act on key issues but say they need to hear from constituents: "Make us do it." Karen mentioned renewed efforts to pass Rep. Chris Gibson's (R, NY-19) resolution on climate change and to find remedies for mass incarceration (http://tinyurl.com/FCNLmass).

Friends World Committee on Consultation (FWCC) — Eduardo Diaz reported. The Traveling Ministry Corps (http://fwccamericas.org/visitation/traveling-ministry.shtml) "is organizing a volunteer corps of Spanish- and English-speaking Friends, to send as traveling ministers throughout the Section, crossing Yearly Meeting lines and other divisions among Friends." "Why Traveling Ministry Is Vital for Quakers in the 21st Century," a QuakerSpeak video (https://youtu.be/1jQK9srrgDs), describes the importance of the program.

Friends for Lesbian, Gay, Bisexual, Transgender, and Queer Concerns (FLGBTQC) — Stephanie Preston reported. FLGBTQC has minuted to begin a jubilee year at the conclusion of the Midwinter Gathering (http://tinyurl.com/flgbtqc2017midwinter) in Portland, Oregon, February 17-20. During this year, regular business will be suspended so that members of the community can focus on listening to spirit to discern way forward on organizational concerns. Stephanie thanked Friends for valuable personal and community support following the Orlando Pulse murders.

Friends General Conference (FGC) – Gerry O'Sullivan reported. "Ripples Start Where Spirit Moves," the 2017 Gathering, will be at Niagara University, NY, July 2-8. Registration opens April 3 (http://www.fgcquaker.org/connect/gathering). SEYM representatives should share this information with their meetings.

Friends Peace Teams (FPT) – Cecilia Yocum reported. "Peacebuilding en las Américas" (PLA http://friendspeaceteams.org/initiatives/peacebuilding-en-las-americas-pla/) seeks \$20,000 in donations for a number of low-cost projects, including AVP and trauma resiliency in Guatemala and support of Salvadoran people with disabilities. Cece can visit meetings and other organizations to advocate for PLA. Carolina Lanker, one of the editors of FPT's newsletter *Peaceways* (http://friendspeaceteams.org/news/peaceways-newsletter/), said that PLA is the "orphan child" of the organization and needs stronger support.

Quaker Earthcare Witness (QEW) — Jack Bradin reported. QEW has given SEYM a copy of Overdevelopment, Overpopulation, Overshoot (OVER) (https://populationspeakout.org/the-book/), large-scale photographs illustrating "the ecological and social tragedies of humanity's ballooning numbers and consumption." [Note: PopulationSpeakout.org will give free copies of the \$50 retail book to organizations which join their campaign.]

Florida Council of Churches (FCC) — Beverly Ward reported (see p.10 of DIA). FCC will convene the Third Florida Interfaith Climate Action Network Assembly, February 23-25 at First United Methodist Church in Orlando (see https://floridachurches.org/interfaith-climate-action-network/). FCC received funding to provide a series of statewide half-training sessions, Faith Reforming Justice in Florida (https://floridachurches.org/reform/).

American Psychological Association (APA) – Eduardo Diaz reported that Cecilia Yocum is now a member of the council of APA's Society for the Study of Peace, Conflict and Violence: Peace Psychology Division (http://www.apa.org/about/division/div48.aspx).

The Recording Clerk read back the Sabal Trail Pipeline minute (17WIBM01), and WIBM concluded with silent worship.

Treasurer Report at 2017 Winter Interim Business Meeting

Report at end First Half of Fiscal Year 2016-17 (June 1 thru November 30, 2016)

All values are rounded to the nearest dollar.

SEYM Total Cash Flow - not including Trustees

The overall cash flow of the Yearly Meeting (excluding the separately-reported Trustees accounts) for the first six months of this fiscal year showed a net <u>income</u> of \$2,271 (excluding unrealized capital gains of \$411 on Publications Program investments), resulting from a total real income of \$40,120 against total expenses of \$37,849.

SEYM General Fund for Administration - Cash Flow and Budget Performance

At the end of the First Half of this fiscal year, the General Fund (the operations fund for which a balanced annual budget of \$69,490 was approved in the 2016 Yearly Meeting sessions) showed a net $\underline{\text{income}}$ of \$3,415, resulting from General Fund total income of \$31,596 (45% of budget) $\underline{\text{vs}}$. General Fund total expenses of \$28,182 (41% of budget).

Budget Support Apportionments & Contributions Received

During the first half of this fiscal year, in response to the annual request for support of the approved General Fund Budget (the Apportionments), contributions received from the Monthly Meetings and Worship Groups totaled \$26,955, or 44% of the annual budget request of \$60,880.

Of the sixteen (16) Monthly Meetings and three (3) Worship Groups which were included in the Apportionment request this fiscal year, at the end of the first six months eleven (11) have responded, including one meeting which has paid its full request.

The unrestricted individual donations received toward the Budget during the first three months were \$1,155, or 58% of the \$2,000 budgeted amount.

Results for Programs

The annual programs during this fiscal year (including the Half Yearly Meeting which occurred near the end of November and involves transactions in December) are in progress, so the cash flow results for this First-Half report are not complete.

The Publications Program during the First Half had a <u>net income</u> of \$598, excluding unrealized capital gains of \$411 on its investments.

The Programs for Youth during the First Half had a <u>net expense</u> of \$580, because the budgeted \$2,500 transfer of support from the General Fund has not yet been done.

The SEYM Field Secretary for Earthcare program by the end of November had received \$2,700 in donations this year and had \$2,799 in expenses, resulting in a net expense during this six months of \$99, and remaining assets of \$20,548.

Net Worth

The combined Net Worth of the Yearly Meeting and its Trustees at the end of November 2016 was \$533,536 (reflecting \$1,882 in liabilities), an increase since the beginning of the fiscal year of \$15,549.



The four-day gathering at Wekiwa Springs State Park from 24 - 27 November, 2015 was a notable success: an opportunity for quiet reflection, physical activity, learning, and political action. Programs were offered that had an emphasis on the environment, global warming, personal engagement and fun.

At the beginning of HYM, many Friends said they had especially looked forward to our Thanksgiving gathering this year, after the political upheaval nationally. There was comfort and soul soothing sitting in the rocking chairs on the porch and Friends kept them in motion as we shared our fears and frustrations from anticipated rollbacks to progress made in the environmental and social justice arenas. The comfort of being among Friends with time to talk was palpable.

Beverly Ward, the SEYM Field Secretary for Earthcare gave a presentation on the Florida Sabal Trail pipeline and Mary Jo Klingel led a worship-sharing on the environment. Kody Hersh reported on his visit to the Standing Rock protest in North Dakota and a follow-up "cell phone action" coordinated calls to public officials involved in putting down the Standing Rock protest.

Three extended canoe/kayak river trips were offered on Wednesday, Thursday (Thanksgiving) and Saturday down the Wekiwa River. Jerry Knutson coordinated. He reports the group saw a manatee as well as a bittern, in-flight. Next year will be the last year for the three days of options for boat owners. However, the rental/shuttle on Saturday will continue into 2018. The Wekiva Springs always has canoe rentals for shorter trips.

The fire risk this year eliminated bonfires, but evening activities continued and presentations and informal games and discussions.

The now mandatory "Untalent Show" on Saturday night reached new levels this year. Presentations ranged from a violin solo to singing to poetry to a Kabuki-ish dance. The weekend ended in worship and centered thankfulness for our Quaker community.

Our bodies were well nurtured as well as out spirits. Our Thanksgiving feast was just that, with tables filled with turkey and potluck delights. Kathy Hersh coordinated the meals. She has created



menus for all our meals to help plan food purchases and arrange volunteer coordinators for each meal. Two 16 pound birds weren't quite enough for our weekend needs for left-overs for the next day's sandwich and soupmaking. A pizza meal on Friday prepared by the young people is becoming a tradition as well as a special finale dinner on Saturday.

The relaxed nature of the HYM gathering is reflected in our registration with people not registering until late, or just showing up for the day. This was an on-going problem for the Registrar.

We counted 39 for dinner on Thanksgiving with about 55 people each day during the weekend. The total number of people that came to HYM 2016 is 72.

We gratefully learned from Katie Green that she will be giving a workshop at the Gathering entitled "Pink Spit." She has a background in giving workshops on racism. Some of the workshop will include participants' exposure to racism at a young age. Susan Taylor will be her elder. We shared information that might be helpful to include in racism workshops and are wide open to learning more.

Shawna Doran shared exciting activity AVP is doing with police and the sheriff's office in Gainesville and carries a concern to spread the word about AVP among Friends and to involve Friends in AVP work in prisons.

Action Request on the Thirteenth Amendment, for Further Seasoning for Suggested Approval at SEYM Yearly Meeting Sessions, 2017

The SEYM Committee for Ministry on Racism asks Worship Groups, Monthly and Yearly Meetings to affirm, and publicize the need for:

- 1. The removal of the exception clause of the 13th Amendment to the US Constitution which otherwise abolishes slavery. Exception clause has been put in bold below.
- 2. Knowledge that the purpose of prisons should be to protect members of society and to prepare those imprisoned to return as productive members of their community through provision of comprehensive education and training.
- 3. Persons formerly in prison to have full restoration of constitutional rights, including access to housing and jobs.

§§§

The 13th Amendment reads:

Section 1. Neither slavery or involuntary servitude, **except as a punishment for crime whereof the party shall have been duly convicted**, shall exist within the United States, or any place subject to their jurisdiction.

Section 2. Congress shall have the power to enforce this article by appropriate legislation.

§§§

We seek this in the light of the Religious Society of Friends (Quakers) testimony on equality and our history of seeking to honor that of God in everyone through justice that restores. Currently, persons in prisons are coerced into working in what amounts to slavery. They leave prison with severely restrictive conditions of freedom that shackle their efforts for normalcy, often for the rest of their lives.

Discernment on Suggesting Funding from SEYM for the Friends General Conference (FGC) Institutional Assessment of Structural Racism

The Committee for Ministry on Racism is supportive of the planned Institutional Assessment that Friends General Conference (FGC) Central Committee has approved for the FGC organization itself, not to include affiliated yearly and monthly meetings. The Assessment will seek to find structural racism within FGC and recommend steps to remove it. FGC Central Committee approved calling the action "Institutional Assessment" rather than "Institutional Audit."

The SEYM Committee for Ministry on Racism will recommend financial support of the Assessment from SEYM once we have heard from the FGC General Secretary, Barry Crossno, that findings and recommendations from that Assessment will be sent to all affiliated Yearly Meetings and Monthly Meetings and that FGC commits itself to following the recommendations that come from its own review.
