SEYM liability insurance ONLY covers SEYM-sponsored events and youth activities. SEYM CAPP registered training may take place at any location approved by SEYM. If a monthly meeting sponsors a youth activity with SEYM CAPP registered leaders, it must have its own sexual misconduct liability insurance.

18WIBMO2 SEYM of the Religious Society of Friends agrees that training for the Child Abuse Prevention Program (CAPP) may be provided at monthly meeting locations within SEYM provided that (1) all required individual paperwork, including background checks, is processed through the Yearly Meeting office before the training occurs; (2) the trainer is an SEYM-registered and designated CAPP trainer; and (3) the monthly meeting holds sexual misconduct liability insurance.

18WIBM03 SEYM of the Religious Society of Friends authorizes the Treasurer to disperse funds in the amount \$5,000.00 payable to Friends Peace Teams (FPT) and earmarked for the Peacebuilding en las Américas (PLA) Coordinator position. The purpose is to provide urgently needed money to support the work

of the FPT-PLA Coordinator. These funds may be taken from the general funds available to SEYM in the most timely manner possible.

The funds of Southeastern Yearly Meeting which are under the care of the Trustees gained value this year after two years of market-driven losses.

There are six Funds with only one being unrestricted.

The dividend income derived from the Funds is used to support the activities of Southeastern Yearly Meeting.

The Bertsche Outreach Travel Fund dividends provided \$1,754 in support for individuals traveling on behalf of the yearly meeting in the 2017-2018 budget year.

The Michener Lecture Fund dividends provided \$841 in support for the 2018 Michener Lecture held in January in Orlando.

The Walton Lecture and Gathering Fund dividends provided \$1,554 in support for the 2018 Walton Lecture held at the annual Gathering (SEYM).

The YM Gathering Youth Endowment Fund dividends provided \$4,012 in support for all of our youth who attended the 2018 Southeastern Yearly Meeting Annual Gathering.

The Secretary's Salary Fund dividends provided \$4,088 for staff salaries (Administrative Secretary and Bookkeeper) in the 2017-2018 budget year, and a similar amount for the 2016-2017 year.

The trustees provided \$5,000 for support of the second year for the Southeastern Yearly Meeting Field Secretary for Earthcare in 2017-2018.

The Trustees are ready to entertain a proposal from the Southeastern Yearly Meeting Youth Committee for partial support for 3 years for a proposed Youth Coordinator position.

- Repeal of the "Dickey Amendment", to allow federal health agencies to conduct research into the causes, effects, and evidence-based prevention of gun violence in our communities, and provide funds for this work though Congressional action.

In Florida:

Repeal Chapter 790.33 of Title 46 of the 2017 Florida Statutes "Field of Regulation of Firearms and Ammunition Preempted", which now prohibits local governments in Florida (Municipalities, Counties, Cities, etc.) from making any regulations more restrictive than the State laws to control guns or ammunition. FLGBTQC 2018 Report

Friends for Lesbian, Gay, Bisexual, Transgender and Queer Concerns

Dear SEYM Friends,

FLGBTQC Midwinter Gathering took place at Camp Young Judaea near Austin, Texas from February 16-19, 2018. The theme of this gathering was "Tis' a Gift to be Simple". Midwinter gathering reminded me strongly of SEYM, with a beautiful setting and a relaxed, worshipful mood. Throughout the day, Friends wandered the surrounding forests and watched herds of deer pass through the campgrounds.

This year's Midwinter Gathering concluded the (2017-2018) "Jubilee year", which was meant to help Friends rediscover our joy of working together. As part of the Jubilee year, the 2018 Midwinter Gathering was unprogrammed. During the 3-day gathering, there was a tour of a nearby state park, an intergenerational dance, a Cabaret/talent show, and several other activities meant to strengthen the community. Optional workshops included 'Friends focused on Prison Reform' and 'FCNL Priorities'.

During the Meetings for Business, friends discussed our role and responsibilities as a community. For several years, the FLGBTQC has sought ways to be more welcoming to Friends of color, and this year we felt led to try something new. This summer at FGC, the FLGBTQC group and the Friends of Color group will hold meeting for worship together, on one or two occasions during the week. Additionally, we will extend a hand of welcoming to the Teen program to join us during one of our meetings for worship.

This past year has brought joys and disappointments regarding current events. Just over a week ago, on Friday, March 23rd 2018, the White House announced a policy to ban most transgender people from serving in the military. The plan currently has no immediate effect, as multiple organizations are currently challenging this policy in court. I ask SEYM to hold the trans community in the light.

Last year, Friends came together in the screened porch to talk about how monthly and yearly meetings can be more inclusive. As we move forward, I hope our communities feel led to use some of these ideas in their local meetinghouses.

- Stating pronouns like she/her or he/him during introductions at conversations/activities
- Providing trans flag and rainbow flag stickers available to put on name tags
- Have books, pamphlets, or other LGBTQ+ resources available in library
- Create a community sign of welcoming near the meetinghouse entrance (eg. outdoor sign)
- Make a list within the meetinghouse of what groups the meeting supports
- Integrate a lesson on LGBTQ+ inclusion into first day school for young Friends
- Have gender-inclusive bathrooms with clear signage
- Donate to community organizations that serve LGBTQ+ individuals
- Marching in an LGBTQ+ pride parade or community event
- Volunteer to host a queer-related community event at the meetinghouse (eg. film viewings)
- Continue financially supporting an SEYM representative to attend FLGBTQC events

Thank you for this opportunity to serve as your representative to FLGBTQC. In this brief year, I have formed relationships with Quakers across the country and reconnected with the Quaker FLGBTQC community in a deeper way. I look forward to joining again with the community at the FGC gathering from July 1-7, 2018 in Toledo, Ohio.

AFSC - South Region 2018 report for SEYM

As the American Friends Service Committee moves into its 101st year the organization is embracing both change and resistance. That change has brought Joyce Ailouny to the organization as the AFSC's first Palestinian-American General Secretary. Joyce joined the AFSC at the end of its Centennial year and is excited to share her vision for our work at a future Palmetto Friends Gathering in the future. In 2017, AFSC worked in 17 countries and 35 U.S. cities. Every day, courageous individuals are coming together to demonstrate the transformative power of love to overcome violence, discrimination, and oppression. AFSC is honored to partner with communities around the globe in pursuing peace and justice. We hope you enjoy these highlights of our accomplishments from the past year and meeting some of the constituents, volunteers, partners, staff, and supporters who make our work possible. This report focuses mainly on activities in the U.S. South as that is the region in which SEYM are located.

The election of Donald Trump and the further right-wing shift of most state legislatures in the South region has driven much of AFSC's work in the region over the past year. These political changes have resulted in immediate threats to the communities that we work in predominantly: Latinx, African-American and low-income communities. Additionally, the pronounced growth and increased visibility of forces of white-nationalism and white-supremacy has been more pronounced in the South region.

In order to protect and defend the rights of the communities that the AFSC is working in we launched several national initiatives including the Communities Against Islamophobia campaign and the Sanctuary Everywhere network. People are pushing back against the rising tide of hateful policies that target immigrants, Muslims, and communities of color—and AFSC is providing them with the tools and training to succeed. Our Sanctuary Everywhere and Communities Against Islamophobia initiatives help everyday people work together to keep each other safe. Through webinars, in-person trainings, and online resources, people are coming together to resist state violence and interrupt acts of hate and fear. The results are impressive. More congregations are now well-equipped to offer sanctuary to those facing deportation, more community members understand how to respond to public harassment, more immigrants and allies know how to exercise their rights, and more schools and municipalities have adopted policies that improve safety for all.

We come to this gathering prepared to aid you and your meetings implement these strategies as individuals and in our communities. A principal resource we would ask that Friends consider in their local social justice work is the Quaker Social Change Ministry. AFSC's Quaker Social Change Ministry (QSCM) serves as a model for congregations and other groups interested in engaging in Spirit-led activism while following the leadership of communities most impacted by injustice. This year, AFSC provided training and resources to more than 125 people in congregations using QSCM tools in their efforts.

Our eight individual programs in the South are working diligently to protect, defend and vision a future without oppression with communities in the region. In Miami and Greensboro we continue to accompany immigrants in their struggle to rebuild a broken immigration system. In West Virginia and Atlanta our economic justice initiative are organizing from community centers to state capitals to ensure that the economic futures of our most vulnerable communities are protected. While our youth organizing programs in New Orleans, Washington DC, Baltimore, Atlanta, Miami and West Virginia continue their work to nurture future generations of active, educated and empowered leaders through their youth organizing activities. Treasurer's Report

Southeastern Yearly Meeting of The Religious Society of Friends

Treasurer Report for 2018 Yearly Meeting

Report for end of First Half of Fiscal Year 2017-18 (June 1 thru January 31, 2018) All values are rounded to the nearest dollar.

SEYM Total Cash Flow not including Trustees

The overall cash flow of the Yearly Meeting (excluding the Trustees' accounts) for this period yielded a net income (excluding unrealized capital gains of \$902 on investments for the Publications program) of \$385, including \$1,500 restricted donation for the Publications program and \$18,522 restricted donations for the Field Secretary for Earthcare program, and a non-budget donation to Friends Peace Teams of \$5,000 with off-setting donations to SEYM of \$700. This resulted from an SEYM total real income of \$72,043 against total expenses of \$71,658.

SEYM General Fund for Administration - Cash Flow and Budget Performance

At the end of this period, the General Fund (the operations fund for which we approved a balanced budget of \$71,680 in our 2017 Yearly Meeting sessions) showed a net income of \$3,032. This resulted from General Fund total income of \$39,835 (56% of budget) against expenses of \$36,802 (51% of budget).

Budget Support Apportionments & Contributions Received

During this period, in response to the annual request for support of the approved General Fund Budget (the Apportionments), contributions received from the Monthly Meetings and Worship Groups totaled \$32,222, or 54% of the year's budgeted request of \$61,870.

Sixteen Monthly Meetings and three Worship Groups were included in the Apportionment request this fiscal year. So far, two have contributed their entire requested amount, seven have contributed one-half to three-quarters, 2 have contributed quarter to half, and eight have not contributed anything.

The unrestricted individual donations received toward the Budget during this period totaled \$510, approximately 26% of the \$2,000 budgeted amount.

A Worship Group with no requested apportionment has donated \$150.

Cash Flow Results for Programs

The annual programs for this fiscal year are in progress; cash flow is incomplete.

The Publications program during this period had a net real income of \$640, excluding unrealized capital gains of \$902 on investments for the program, and a restricted donation of \$1,500.

The SEYM Field Secretary for Earthcare program during this period received \$18,522 in donations and had expenses of \$13,257, yielding a net income of \$5,265.

Net Worth

The Net Worth of the combined Yearly Meeting and its Trustees at the end of this period was \$575,901, an increase of \$35,030 including \$27,244 in unrealized capital gains since the beginning of the fiscal year.

From Warren Hoskins, SEYM representative to the Historic Peace Churches in Florida

The Historic Peace Churches program committee has been unable to meet this year or last year, and telephone and email communications have not sufficed for planning a gathering. Recent correspondence from Phil Lersch, the founding coordinator, states that he is having to remove himself even further from activities. I am unable to pick up this coordinating work and there is no one else stepping forward. Phil and I agree it is time to lay down the Historic Peace Churches program, and cease requesting support for it from the three bodies - SEYM, the Church of the Brethren and the Mennonites - and it is my recommendation to SEYM to end support for the program now.

Phil reports that there is a balance in the HPC account at the Church of the Brethren (funds held earmarked for the Historic Peace Churches work) of \$352.12. This is the remainder of contributions from each of the three bodies -SEYM, the Church of the Brethren and the Mennonites - that were given over several years to fund planning meetings and to set up and carry out gatherings of the Historic Peace Churches in Florida. I believe we had six of these gatherings through the years, the last coordinated by Tom Guelcher who had some contact with Fort Myers Friends, I recall. No funds have been requested the past year.

Phil will notify the Treasurer of the Church of the Brethren to write checks to each supporting body for one third of the funds. Phil will communicate first to ascertain how checks should be made out and where they should be sent.

This may be my last report as representative from SEYM to the Historic Peace Churches in Florida, although one more may be needed to wrap up the finances. I can say that my participation in the gatherings of the Historic Peace Churches in Florida was more valuable to me than ever anticipated, and that, given the distances between cities in Florida, the inability to go on indefinitely (as all of us steering committee volunteers aged and newer younger volunteers did not come forward) was not a surprise.

There are reports in the SEYM files of the gatherings held, and Friends can remember the volunteers from each of the bodies with gratitude for the work done, the communities connected, and our shared history celebrated.

One other recommendation – when you are thinking of worshipping with another body on one of the intervisitation Firstdays, consider going to a Mennonite Church or a Church of the Brethren. I can testify that we are kindred in the

Greetings from the Committee for Ministry on Racism,

We met yesterday afternoon and affirmed the founding mission of the Committee: To increase awareness of racism personally, within our communities and among Quakerdom. At future meetings, some of which will be by Zoom teleconferences thanks to Field Secretary for Earthcare, Beverly Ward (Tampa MM), we will develop goals and actions to achieve those goals. We welcome input on goals and actions from all of you in our Southeastern Yearly Meeting family.

We had conversations about our experiences with racism and white privilege and would like to facilitate such conversions more widely among SEYM Friends.

We encourage Friends to visit the Committee for Ministry on Racism display at the back of the auditorium.

We noted that some of our past actions are continuing:

- We invite all SEYM Meetings and Worship Groups who have not already done so, to begin a conversation about racism and White privilege by reading together and responding to the queries in Patience Schenck's Pendle Hill Pamphlet No. 415: Living Our Testimony on Equality: A White Friends Experience. This action request began two years ago. A link to Peggy McIntosh's classic paper, White Privilege: Unpacking the Invisible Knapsack is now available on the Committee for Ministry on Racism's website. Copyright prohibitions prevent posting of the paper itself. We recommend that all Friends read this as well.
- The Baltimore Yearly Meeting Working Group on Racism is in conversation with our committee regarding SEYM's minute from 2017 on removing the exception clause to the 13th Amendment to the U.S Constitution in order to end enslavement as it is practiced in prisons. We encourage Friends to contact their Senators and Representatives regarding this.
- Wendy Clarissa Geiger's document, What White folk can do about racism and making Black Lives Matter is now available as a Word document for Friends who would like to have ideas about what white people can do to address racism pertaining to black and brown people. It is an offering from Wendy Clarissa to all SEYM Friends, targeted toward those of us who identify as White. A copy can be found by the Committee for Ministry on Racism display. The committee was able to review much of the document and was grateful for Wendy's efforts. We looked at language and some shared that using the term "People of Color" represents a uniting term to them of all people who are not White. Another view expressed was that some Friends are led to work solely with racism as experienced by Black people.
- We recommend that all Friends take the on-line test regarding "hidden biases" (Implicit Association Test addressing race. Harvard), which is on Wendy's list. Two of us on the committee found it valuable to take.
- Some of us have also learned deeply from Michelle Alexander's Book, The New Jim Crow- Mass Incarceration in the Age of Color Blindness, on Wendy's list and the FGC bookstore table in the lobby. We suggest Friends read it.

The committee is very grateful to Jane Westberg and Kody Hersh (both of Miami MM), who will be leading the workshop at 10:00 AM, Saturday the 31st on Roots of Injustice, Seeds of Change: Toward Right Relationship with Native Peoples. This presentation was deeply inspiring to Friends who participated in this at Half-Yearly Meeting, 2017. We heartily encourage Friends to attend.

We look forward to continuing conversations with all Friends about racism and the intersectionality of all forms of oppression with racism. Please share your ideas with us and ways to move from ideas to actions.

Hayley Hathaway doesn't have quite a year as the new director in the Quaker Earthcare Witness office and she has had a very position impact on the productivity of the organization. She is young, bilingual, a Friend, and very committed.

Rising Clerk is Maryjo Klingel. Please hold her in the Light.

Minigrants committee, of which I am co-clerk with Maia Wolf, continues to be active. It has provided support to an inner city eco-justice project, a film of a reforestation project in Uganda, and two grants went to Monteverde Friends for the school and the Meeting for restoration of their sewage system after the hurricane and for a water collection system.

Minigrants is encouraging Meetings and worship groups and other Friends organizations to reach out and request a Minigrant. It is very simple now with downloadable, fillable, application form and clear easy steps. If you need any help, reach out to the clerks of Minigrants and we will help you with ideas and with the application if you need it. We encourage you to consider working with others in the community for a joint project.

We are working on a packaged presentation, a power point, about Minigrants that should be available this year.

Quaker Earthcare Witness broke even on the budget with some last minute significant donations. Quaker Earthcare Witness now has the ability to accept stocks as donations and several Friends have donated in that manner. There is one case where a Friend was divesting fossil fuel stocks and donated some of them to Quaker Earthcare Witness which immediately sold them. Think about it.

Quaker Earthcare Witness is currently in discernment about vision for the future direction of the organization. If you have any comments or suggestions, please forward them to Jack Bradin and Brad Stocker who are on the ad hoc vision committee.

Quaker Earthcare Witness is not yet near the recognition level nor operational size of FCNL or AFSC for example. Surely, the cause of Earthcare is significant enough to warrant more attention and support than it currently has. Please, help raise Quaker Earthcare Witness awareness in your respective spheres.

Quaker Earthcare Witness asks that each group in our yearly meeting have a contact person for Earthcare and that the contact information is shared with the Quaker Earthcare Witness office. We here add to that suggestion that the same person be the contact for the Field Secretary for Earthcare and for the SEYM Earthcare Committee.

There is a "speakers" bureau. Someone from Quaker Earthcare Witness will come to your meeting for workshops, presentation, and in our case we have a dual role person in our Field Secretary for Earthcare. Please ask for her to come to your Meeting or group.

Our next Quaker Earthcare Witness meeting is in April in Chicago.

Please check out the Quaker Earthcare Witness display table. Those items marked as display only usually can be made available on request. Some books can go home with someone at the end of the end of the gathering.

Quaker United Nations Organization (QUNO)

report and recommendations to SEYM 3/29/2018

I have been SEYM's Representative to QUNO for 2017 and 2018, and this Yearly Meeting is the second at which I have been able to make a presentation about QUNO. During this whole time, I have not been able to go to New York City to the QUNO offices and Quaker House (let alone go to Geneva, Switzerland, to see those offices and the Quaker House there).

Fortunately, ever since I took on the role, I have been able to speak frequently with Eduardo Diaz, also of Miami Friends Meeting. Eduardo has been volunteering with FWCC, which is over QUNO. He has made journeys to New York and stayed at Quaker House more than once, and he has met staff at the QUNO offices there (and he hopes to go to Geneva this summer). Eduardo has freely answered questions for me, and inspired me.

I have kept in touch with QUNO for SEYM presentations by telephone and by email, and by research visits to the QUNO website. I have asked for and received written materials from QUNO to distribute last year and this year at Yearly Meeting. For SEYM in 2017 the QUNO New York office sent me a PowerPoint presentation with 15 slides. Fortunately for us, Eduardo was at SEYM last year, and he came to my presentation to assist. He provided history, personal experiences, excellent insights and additional information, as I showed the slides and added what I had learned.

This year for SEYM gathering, I received 5 more slides on the new international compact on migration, and this year Eduardo was again able to be present and assist with the presentation. I was able to show the slides from last year again, plus the new ones, and still have ample time for those present to share personal experiences and insights, ask questions and engage in helpful discussion. These contributions made for informative and enjoyable programs for SEYM Friends.

A word about QUNO from another website, Quakers In The World: http://www.quakersintheworld.org/quakers-inaction/22/QUNO-Quaker-United-Nations-Office

QUNO organises its work into broad areas. In 2014 these were defined as justice and prisons, human rights and refugees, peace building and prevention of violent conflict, human impacts of climate change, and food & sustainability. These areas are not independent - for example, work with refugees is likely to involve concern about the violence and/or economic challenges that uprooted the refugees. Nevertheless the areas provide a useful focus, and are redefined from time to time as circumstances change. In 2017 the areas of work are much the same, except that justice and prisons work is now included in the human rights and refugees area. A previous area, now laid down because the work has been picked up by UN agencies, was international trade and development.

The new materials from QUNO this year included information about the new international compact that is in process of development by all the nations. All nations are already signatories to an international compact on the right treatment of refugees. There are practices and procedures agreed to, and expectations (often not easily or willingly fulfilled but nevertheless agreed-to in advance). Now the concern is that there are tens of thousands or even hundreds of thousands of people uprooting and moving, many across national borders, who do not meet the definition of "refugees" - they are migrants, and there is no agreed-upon framework, no universal policies and procedures, for nations to welcome migrating peoples or individuals.

The US hosted the initial call for such a compact, and nations took up the New York Declaration:

"New York Declaration for Refugees and Migrant"

In the New York Declaration for Refugees and Migrants, adopted in September 2016, the General Assembly decided to develop a global compact for safe, orderly and regular migration. The process to develop this global compact for migration started in April 2017. The General Assembly will then hold an intergovernmental conference on international migration in 2018 with a view to adopting the global compact.

The global compact is a significant opportunity to improve the governance on migration, to address the challenges associated with today's migration, and to strengthen the contribution of migrants and migration to sustainable development. https://refugeesmigrants.un.org/migration-compact

The Declaration set in motion the process for drafting the compact. An initial draft compact has already been completed, and a first revision. The intention is to have a compact done as soon as possible and get it adopted.

I explained this at the workshop yesterday and shared literature from QUNO about it; I plan to provide writing for the SEYM newsletter for the further education of Friends, that we may be maximally supportive of this vital work of the Quaker United Nations Office.

(I have asked Eduardo Diaz to say a few words more after I submit this report, about support for QUNO.)

[Eduardo said Friends should go on line with QUNO and sign up for their newsletter, In & Around the UN, or download and print it out. He also explained the situation with funding for QUNO and asked Friends to study QUNO's work in their monthly meetings with an eye toward increasing support, individually, from monthly meetings and ultimately from SEYM.]

I made a recommendation that the concern for an increased donation from SEYM be referred to the SEYM Finance Committee; at the Clerk's direction it will be taken up by SEYM Peace and Social Concerns Committee at FIBM for discernment about how much to suggest be contributed, if there is unity on the Committee.

2018 Gathering Committee Report

The Gathering Committee delegated me to provide this end of gathering report to you. There is a lot of work that goes into the holding of a Gathering. The Committee's quiet dedication in the weeks and months leading up to our time together is what created this sacred space, brought you the bookstore, checked you in and assigned your rooms, and made sure the programs happened. Andrea Hoskins, besides serving as co-clerk, once again managed the registration process. Gerry O'Sullivan managed the Bookstore. I served as Program Coordinator. And our Yearly Meeting Secretary, Vicki Carlie, probably spends more time assisting our committee than any other. There is another person – Stephanie Preston-Hughes, our co-clerk. Stephanie was called away to Ohio in the last week or two because of a family health crisis. That is why she is not here giving this report. But Stephanie worked tirelessly all year, and is still keeping tabs via e-mail, text and voice calls.

Our 2018 Attendance Summary: We had 116 registered adults and 11 children for a total of 127. This falls short of last year's registrations of 141 adults and 21 children by a total of 35. We all have a responsibility to encourage other Friends from our monthly meetings and worship groups to come to part or all of the Gathering.

2019 SEYM Gathering: Our next Gathering will be held on April 17 to April 21, 2019. The theme of the 2019 Gathering will be "Achieving Equality."

In alignment with that theme, our Walton Lecturers will be Lucy Duncan and Noah White. Lucy is the Director of Friends Relations for the American Friends Service Committee. Noah is a Quaker-raised Professor at Temple University in Philadelphia. The two together have traveled to various Yearly Meetings to facilitate conversations on issues of equality, racism, and white privilege. Friends may wish to read the article "Stumbling Forward Toward Racial Justice among Friends" co-written by Lucy and Noah in the March 2017 edition of Friends Journal. The tentative title of the Walton Lecture is "Undoing Racism as Personal and Community Practice. Lucy & Noah (as a white woman and a bi-cultural man) will tell deeply personal stories which delve into the dynamics of growing up in a system that uses us to perpetuate and receive harm in our families, communities, and society. They will explore the sometimes quite intimate way white supremacy is transmitted and the healing that has happened for each of them. They will talk about their shared work in the Quaker community to hold others as they struggle toward and resist their liberation.

Evaluation: As most of you know, following every Gathering we ask you to evaluate it: what worked, what didn't, what excited you, how the facilities were, etc. We use these evaluations to plan a better Gathering for next year. Beginning last year our Yearly Meeting Secretary e-mailed all attenders with a link to an electronic form. Using that method facilitates the compilation of the evaluations. For those of you who are not e-connected or otherwise would not complete an evaluation on-line, we have a small number of paper evaluation forms on the table in the lobby, which you can complete and leave in the box.

I cannot end this report without reminding Friends that Stephanie Preston-Hughes is ending her role as Gathering Committee co-clerk and, as you heard today from the Nominating Committee, we do not have a replacement. Andrea, our other co-clerk, cannot serve both as registrar and single clerk. This hole will have a most serious impact on the 2019 Gathering. So please help the Nominating Committee in discerning a replacement.

He is Quaker, grew up in Palestine, and is also an LGBTQ rights activist. His lecture "Quaker Response in Turbulent Times" used a multimedia presentation and his life experience. The role Ramallah Friends school played in assuring him an open and affirming school experience as a child in an land of occupation made us realize that the school we have made contributions to is vitally important to both Muslim and Christian children. He used the Pulse nightclub massacre and the different media portrayals of the shooter to bring his theme close to home. We thank Sa'ed Atshan for sharing with us how we as Quakers can respond to systemic injustice and oppression, speaking truth to power, without demonizing the people involved in these systems.

Supporting the student led March for our Lives, SEYM Friends send with this epistle our minute speaking to the moral need for legislation and action against the epidemic of gun violence. We stand with the students saying "Never Again."

Our daily worship sharing was guided by both readings and queries that offered blessed food for deep reflection and sharing. Our worship grounded meetings for business allowed us to address the ongoing responsibility of working together to strengthen the processes, structure and foundation of SEYM.
