# Yearly Business Meeting 2024

27 to 31 Third Month 2024

### **MINUTES**

### First Plenary – 27 Third Month 2024, 7:00 p.m.

The clerk welcomed everyone and invited all into silent worship at 7:07 p.m. He then opened the plenary from the silence with the following quote:

If we desire a society in which men are brothers, then we must act towards one another with brotherhood. If we can build such a society, then we would have achieved the ultimate goal of human freedom.

Clerk invited Friends to speak from the silence as led.

Gary Arthur shared about **Gainesville Monthly Meeting**. Three new children, a young couple, and several visitors are coming often. A zoom aspect has been added. Gainesville is meeting in the meetinghouse as well as the surrounding woods. A Quakerism 101 study group is underway. Good things are happening in Gainesville – come visit.

Clerk shared that **Saint Petersburg Quakers** acted on the issues of Reproductive Health Care and the Israel-Palestine conflict. The meeting has received new Light from young attenders. Lively discussion about how to facilitate Adult Sunday School. A new positive energy flows through the meeting . The meeting seems to have recovered from COVID.

Lisa Erazmus report that **Tampa Monthly Meeting** lost a member, Roy Yerrakuda, who passed during the last year. Cece Yocum reported that they were able to mobilize people in Hillsborough County to get police to not put young people in jail, like a young girl lying on the floor of the jail because she was sleeping in a park. Making progress in getting housing, jobs, and funding about the needs of the homeless. Quoted King to suggest people step out of comfort zone and make clear the changes we would like to see happen in our society. She remembered that the Hillsborough County Commission wanted to buy low-income housing in order to kick out the poor people so they could put some in more upscale housing. She asks, "What gifts do we have that we can bring to this issue?"

Phil Stone on behalf of **Clearwater Monthly Meeting** reported that they have lost a few couples. Some who had not been as active before, are now filling in that gap. Have 30-50 people coming together regularly to talk about interfaith activity. No younger people or children. Energy, however, seems to be higher than it has been in past few years.

Hope and Larry Ascher of **Quaker Meeting of Melbourne**, speaking online, are grateful for the Zoom feature of the Gathering. Melbourne has an active book club that meets weekly. They are learning and sharing through that activity. About 7 people attend in person and 3 attend virtually each week. Feel led to continue. Mostly elder members and attenders. They occasionally discuss what happens when we die. Some struggle with hybrid meeting – struggling to make sure it doesn't become two meetings for Worship. There are occasional Meetings in a public park on the river. They are appreciated. They sit around a picnic table, in silence. They use signs to identify themselves, explain the gathering, and state that all are welcome. They are concerned about the direction in which the State of Florida is heading. They want to at least be a witness that some do not agree; that with us, ALL are welcome.

Bob Allenson from **Tallahassee Monthly Meeting** expressed delight to be here with Friends. Susan Taylor reports that Tallahassee has three children in attendance. Four members form a Youth committee. They discerned and wrote an 1/4-page ad on the Israeli-Palestinian conflict that ran for 4 days in the Tallahassee Democrat. Some positive feedback, with people coming to the Meeting in response to that ad, making donations. They are active in a Food Network – community garden in underserved part of Tallahassee and contributes fresh vegetables to the community garden and to a food bank. Susan helped with a camp held for children in cooperation with other faith communities in Tallahassee. She started a new book group about Israel. The book helps to understand history and dynamics in way not often found. They have a listening circle once per month, sharing personally how Spirit is moving within us. It builds closeness. They are working with the United Church of Tallahassee on LGBTQ issues. They are also part of a group working for affordable housing and to address increasing gun violence in Tallahassee.

Phoebe Andersen added that Tallahassee gets together once per month for one hour to hold a person or several people in the Light. It is developing a practice of spiritually opening our hearts. It engages everyone in the Light. Out of that comes a closeness and sharing that we love each other. It has begun a spiritually deepening experience.

nova george, visiting from **Friends General Conference (FGC)**, announced that FGC would like to hear what meetings are doing in order that they might offer help. Please let her know how FGC can help, and she will take that information back to them.

Brian Olson from **Miami Monthly** Meeting reported that the Meeting lost quite a few people during the pandemic but recently new people have begun to attend, including 3 children. They are working together with other houses of worship and other Quaker organizations. They have met with a representative from Friends Committee on National Legislation, their Congressional representative, and are active with Quaker Earthcare Witness. They also have created a new website: <a href="https://miamifriends.org/">https://miamifriends.org/</a>. Check it out.

Ed Lesnick read a Letter from Alejandro Gonzales, Clerk of **Havanna Unprogrammed Worship Group** (attached).

### Second Plenary – 28 Third Month 2024, 4:30 p.m.

Clerk Bill Carlie opened the session from silence at 4:30 p.m. with the following quote:

The clerk called for volunteers to write the annual epistle. Ian MacDonald and Amy Richards volunteered. One additional person will be named later.

### Treasurer's Report

Joel Cook gave the report (attached). Jean asked whether he had information about the apportionments. Answer no. Report sounded really good. However, he pointed out that the approximately \$16,000 had yet to be paid to DaySpring and that the youth workers had yet to be paid. Joel made an appeal for donations and asked Meetings to send their apportionment payments.

Treasurer requested a transfer of \$700 from the Contingency Fund to the International Worship Group Support Fund. Request is a result of having spent more money from that fund than we had received in donations. Money has already been spent.

Funds in the amount of \$700.00 can be transferred from the Contingency Fund to the International Worship Group Support Fund. Approved.

Joel next gave the Budget Report (proposed budget attached). The proposed Budget is about \$1500.00 higher than it was for last year.

Volunteers are need on the Finance Committee. Joel would like to propose amendments to the budget but lacks a fully populated Finance Committee to whom he can make the request. Neil advised that people should not be worried that they need certain qualifications for membership on the Finance Committee. There is abundant staff assistance for the bookkeeping, reporting, and planning issues. The Finance Committee is needed only to make policy recommendations to the yearly business meeting.

Joel's request relates to the Havana Unprogrammed Worship Group. The news from the worship group is that those supporting the worship group need financial help. Joel would like to add \$1,000.00 to the budget for the International Worship Group Support Fund thus creating a basis for the fund. That would change the budget from \$117,000.00 to \$118,000.00.

The Treasurer's request will be treated as a request for the yearly meeting as a whole to amend the budget. The Treasurer's request will be brought back for second reading.

Eileen asked if we already had a budget for this purpose. The answer was no – the only budget item was for Havana Unprogrammed Worship Group alone, not for the International Worship Group Support Fund. Individual donations to that fund would require no budget amendment approval from yearly meeting.

Havana Unprogrammed WG needs aid for medications, food, and to help fund individual cell phone service that allows Havana Unprogrammed WG attenders to join SEYM's First Day Online Meeting for Worship. This would be a continuing annual expense.

Phil Stone asked whether there was a more structured way for raising funds? The answer was no, but such help is greatly needed, and would be gratefully received.

The first reading of the annual budget was approved. **Report accepted.** 

### **Nominating Committee Report**

Ed Lesnick, clerk, referred to the committee's report (attached) in the Documents in Advance. Friends were asked to contact the members of the Nominating Committee: Beverly, Shawna, Brian, and Ed, for questions, applications, nominations, and suggestions. Ed reported that Brian Olson would be nominated to serve as the new Clerk of Nominating Committee.

A question was raised about Ann Jerome's position on Worship & Ministry Committee. Cheryl Demers-Holton answered by saying that Ann was is still active on the SEYM Worship and Ministry committee and continued to maintain her membership at Orlando Monthly Meeting, despite currently living as a Friend in Residence at Pendle Hill, Pennsylvania.

Report accepted.

The Meeting closed with silent worship at 5:14 p.m.

Clerk opened the plenary at 3:33 p.m. from the silence with the following quote:

The Plenary began with the Roll Call of Meetings and Worship Groups followed by announcements.

The 2023-2024 Executive Committee and Interim Business Meeting Minutes (attached) were approved as published in the Documents in Advance. Approved.

### **Youth Committee Report**

There was no report presented.

### Ad hoc Committee on Youth and Young Adult Coordinator Report

Vicki Carlie referred to the committee's report (attached) published in the Documents in Advance and read portions. The committee proposes to hire a 1/4- to 1/3-time YYAC with backup funding from the Trustees, in a separate program, to coordinate youth activities in SEYM and to assist monthly meetings in building active youth and young adult programs.

The clerk described the process involved in the committee's proposal. If Friends approved the concept of hiring a Youth and Young Adult Coordinator, the Trustees will fund the position for up to \$20,000 for three years but additional private donations will also be needed. The Treasurer recommended that SEYM handle it as a separate program. If there is interest and support, the position could be made full time. The Trustees want to know how much REAL interest there is in the program.

There followed a lively and lengthy discussion but there was no sense of unity and the Clerk suggested that the report be set aside until the Fifth Plenary, with the request to the committee to bring back a proposal on which we can unite.

Report accepted.

### **Peace and Social Concerns Committee Report**

Warren Hoskins gave a verbal report asking the yearly meeting to adopt the Statement on Conflict in Israel-Palestine, submitted by Tallahassee Monthly Meeting (attached), and the Minute on Reproductive Rights, submitted by Saint Petersburg Monthly Meeting (attached), and publish the statements as widely as possible.

### **Worship and Ministry Committee Report**

Lisa Erasmus referred to the committee's report (attached) published in the Documents in Advance. There are two major programs coming up: Growing in Spirit Led Action, facilitated by Tim Gee, and Wade In the Water, a 3-part spiritual series facilitated by Ann Pomeroy. Susan Taylor

added an expression of gratitude to the committee and how they are deepening the spiritual connections of our meetings.

Report accepted with gratitude.

### **Committee for Ministry on Racism Report**

Kathy Hersh reported that the committee continues support of establishment of a federal commission to investigate the Native American Boarding School issue. The Carlisle School in Saint Augustine was a place where Native Americans were imprisoned. The committee and the Saint Augustine Worship Group are investigating whether Quakers were involved. The committee is also looking for a Native American speaker for the Walton Lecture. Other topics mentioned: Walking history tour with Marvin Dunn and the Banned Book Giveaway, a very rewarding effort for the DeLand Worship Group (DWG). Lee County Administrator was contacted. He had quit over the School Board's confiscation of 600 books from his library. Kathy has more information on that, upon request.

Susan Taylor presented a report (attached) about a gift to California Heritage: Indigenous Research Program to help return Native American land to the Tribe from which it was wrongfully taken and presented a proposed minute.

### **24YBM04**

Southeastern Yearly Meeting of the Religious Society of Friends approves a \$500.00 donation to the *California Heritage: Indigenous Research Program* (*CHIRP*), the nonprofit raising funds to purchase the Sierra Friends Center in order to return to the Nevada City Rancheria Nisenan Tribe, their ancestral land, Yulica. We encourage individual Friends, Meetings, and Worship Groups to donate also as led. We are grateful to the Santa Cruz Friends Meeting for alerting Quakers to this opportunity to help redress inhumane wrongs done to the Tribe by the state and federal governments from which Quakers were among the beneficiaries. We will inform the clerks of Santa Cruz Friends Meeting, Hans Brinker and Nancy Wood, of our donation. **Approved.** 

Kathy recommended a book "The End of Bias: The Science and Practice of Overcoming Unconscious Bias," by Jessica Nordell and a workbook given out during DWG book giveaways: "Kids Can Help End Racism," an Educational Activities Book.

Cindy Kwalwasser reported briefly on the workshop entitled, "An Affinity Group for White People." Handouts from that workshop were available outside in the hall. They contained 39 questions to ask of white people. Cindy encouraged Friends to have a conversation with someone about those questions..

### Report accepted.

Friends waived a second reading of the approved Committee for Ministry on Racism minute.

The meeting closed with silent worship at 5:28 p.m.

### Fourth Plenary – 30 Third Month 2024, 10:00 a.m.

The clerk opened the plenary from the silence at 10:10 a.m. with the following quote:

### Ad hoc Quaker Call Committee Report

Dan Vaughen reported for the ad hoc Quaker Call Committee. He introduced the committee members present, hoping that as Friends reflect on the work of the committee they will contact committee members.

The committee was created at Fall Interim Business Meeting 2023 (FIBM) in order to discern SEYM's work. Dan read the charge given at Winter Interim Business Meeting 2024 (WIBM). Since its creation, the committee has met every two weeks. They have heard from various speakers, including from Friends Council on Education and Lancaster (PA) Friends School. They have researched micro schools and teaching diversity, equality, and inclusion (DEI) through nature walks. Unlike the Quaker Call Committee, which has a national focus, this group has a local focus, to respond to local rulings and events that run counter to Quaker testimonies. The committee survived a proposal to be laid down at WIBM when a Friend related an experience his son had in a Florida public school. Friends realized that SEYM must find ways to support all of us who want to live a life into the Friends testimonies, whether quakers or not.

Dan asked all Friends and meetings to hold the committee and its work in the light. The time is now. Dan related the story of Isaiah [Isaiah 6:6-8]. Our lips have also been touched by burning coals. Consider how you can support us. A Friend asked that more information to meetings and Friends to make them more aware of the work and needs of the committee.

Friends accepted the report.

### Ad hoc Organizational Documents Committee Report

Dan Vaughen reported for the ad hoc Organizational Documents Committee. The committee was created by FIBM 2023 to review the organizational documents to ensure that they are up to date, in agreement with each other, and comply with both Faith and Practice and state law. The committee has met weekly by zoom and made a page-by-page review of the documents. It is now also reviewing the draft personnel policy.

Committee clerks are asked to review the handbook for descriptions of their committees for accuracy. Many descriptions are out of date. Please contact committee members with suggested corrections and additions.

Friends accepted the report.

Recognition of Representatives from other organizations:

### Friends Committee on National Legislation (FCNL)

Riley Robinson spoke on behalf of FCNL (annual report attached). Hundreds of thousands of messages are flooding Congress through the FCNL system. Congressional Staff say Friends should keep them coming. They are making a difference. Another focus of FCNL is the Native American Schools project. FCNL is holding space for people to heal and to move together toward a resolution. He expressed thanks to Friends for their continued support.

Riley explained how online messages make a difference: The typical response of the U.S. to conflict overseas is to send in the military. That never works. The State Department is as divided as Congress is over the conflict in Gaza. A huge flood of messages brought about a much earlier change from the militaristic solution. The administration is now investing much more time in diplomacy. They are still throwing weapons at it. But there are now more diplomats doing really effective work.

Mira Tanna pointed out the connection between our need for outreach and the opportunities presented by cooperation with FCNL. Brian Olson also encouraged Friends to volunteer with FCNL - and gave another example of how FCNL can help by providing factual information us with monthly meeting advocacy groups. Amy spoke on behalf of her Jewish family, her Arabic friends, and her Native American heritage ate express a big thank you to FCNL for their work. Richelle added her thanks, having herself noticed how militaristic the response began, and how it has changed, thanks to the efforts of FCNL. Ian MacDonald, SEYM's representative to FCNL, underlined the impressive effort and process FCNL contributed to the debate on reproductive health care. Eileen asked Friends to complete the FCNL priorities questionnaire. The deadline is April 15. Congressional staff is listening closely to FCNL. They have an important impact on the legislative e process. Karen Putney added her thanks to them, and to the Nominating Committee which started her involvement with FCNL 27 years ago. She wanted to correct our language: FCNL is not "THEY"; FCNL is "US".

### Friends General Conference (FGC)

No report is given because nova george, FGC representative, is busy with the Youth.

### Friends World Committee for Consultation (FWCC)

Joel Cook, SEYM's FWCC representative, reports that he plans to attend the World plenary in August. Most of the World's Quakers are in located in Africa. Africa also has the most Christians in the World. The theme is Ubuntu: "A person is a person through other persons. I am because we are." The theme evokes Unity and Interdependence. He thanks the yearly meeting for the opportunity to serve as representative to this organization.

### Friends Peace Teams (FPT) -

Cece Yocum reported that FPT has been invited to Cuba for a lead an Alternatives to Violence workshop. FPT is leading workshops all over Central America. Cece made a request for donations to help FPT attend and facilitate those workshops. FPT needs \$300-\$500 for room and board and transportation to facilitate the workshop in Cuba, perhaps more. She plans to get some estimates

of the costs. Clerk asked Cece to provide a specific dollar amount. Clerk suggested that a specific dollar figure and a minute be presented during the 6th Plenary on Sunday morning.

### Quaker Volunteer Service (QVS)

Hilary Burgin, Executive Director, reported on behalf of Quaker Volunteer Service. QVs runs programs in Boston, Philadelphia, Minneapolis-St. Paul, and Portland, Oregon. Their programs relate to Healthcare, Homelessness, and Faith development, depending upon the local need. Changes are happening. She offered to talk more with Friends individually, about their work.

### **Quaker House**

Wayne Finegar, Executive Director, explained that Quaker House is a 55-year old project based in Fayetteville, North Carolina, designed to help heal the damage done by war, as well as help end wars. Military service makes lifelong changes to people's lives. That is a new facet of the services Quaker House provides. These services are nationwide in scope. The purpose of Quaker House is to share their knowledge and experience with others who are engaged in similar work. He has met, and is thrilled to work with, the new SEYM representative to Quaker House, Seth Moody.

### Right Sharing of World Resources (RSWR)

Megan Fair reported that the organization was founded by FWCC in late '60s. Friends then felt a calling to bring Friends together to share God's love. RSWR attempts to build equity in two different ways: first, to hold space for thinking truly and deeply about our own personal choices and how those choices are rippling outward. They have a website to provide information about their work. Second, is to partner with 11 coordinators in many different countries to provide loans to women who work to support themselves and to provide services to others. They are also looking for new leadership for Right Sharing as the current Executive Director is retiring.

### Field Secretary for Earthcare (FSE) Report

Beverly Ward referred all to the FSE report (attached) in the Documents in Advance and emphasized that the report includes her announcement of her intention to retire at the end of FIBM 2025. Kathy Hersh will serve on a search committee for her replacement. **Friends accepted the report.** 

### **Publications Committee Report**

Phoebe Andersen reported on behalf of the committee: Phoebe, John Palozzi, Steven Riddle, and Vicki Carlie (ex officio). John Palozzi will help catch up the publication of SEYM lectures. Michener Lectures will no longer be published as a pamphlet but will be available as videos or .pdf files. It has become prohibitively expensive and very time-intensive to publish the lectures in hard copy. Friends accepted the report with gratitude for the committee's work.

### **Archives Committee Report**

Phoebe reports there have been no changes since committee clerk Bill Rapp's report was presented at the FIBM 2023. Archives committee plans to return to the University of Florida to continue their work in August when students are gone and the archives are closed to the public. Friends accepted the report with gratitude for the committee's work.

The plenary closed with silent worship at 4:45 PM.

To support the efforts of New England Yearly Meeting and Southeastern Yearly Meeting, SEYM approves a donation of \$1,000.00 to Friends Peace Teams, Peacebuilding en Las Americas to bring Alternatives to Violence Project training to Friends in Cuba. The funds should be sent immediately, without waiting for supporting contributions.

### **Nominating Committee Report**

Brian Olson presented the final committee report (attached) noting that one member of the Finance Committee is not a member of a constituent monthly meeting.

Friends approved the report.

### **Finance Committee Report**

Joel Cook noted that other than the \$1000.00 transfer to the International Worship Group Support Fund there have been no changes to the proposed budget presented during the first plenary.

Joel Cook estimated, for the benefit of monthly meeting treasurers, that the approved budget will work out to an apportionment of approximately \$220.00 per member and \$110.00 per attender. That will represent a small increase from last year. For a perspective, the total budget increased by about \$3,000 over last year's budget.

Friends approve the 2024-2025 budget including the \$1,000.00 transfer.

### **Gathering Committee Report**

Vickie Carlie reports that the Gathering went smoothly and on time. There were about 97 people in attendance.

The committee needs volunteers to take over the positions of Gathering Committee Clerk, Gathering Registrar, and a paid Logistics Coordinator to manage the logistical issues.

The "Pay-as-Led" system is falling far short of covering the expenses for the Gathering by thousands of dollars. More individual contributions are needed to reduce that deficit. Suzanne Frechette recommended that families in particular consider using nearby campgrounds for inexpensive accommodations. That might enable some Friends to attend without relying upon the Pay-as-Led policy.

### Friends accepted the report.

Appreciation was expressed by the online community for the virtual meeting technology and for the work of those who labor hard to support it.

# Treasurer's Report Southeastern Yearly Business Meeting 27 – 31 Third Month 2024

Report for end of Three Quarters of Fiscal Year 2023-24(June 1, 2023 thru February 29, 2024) All values are rounded to the nearest dollar.

### SEYM Total Cash Flow not including Trustees

The overall cash flow of the Yearly Meeting (excluding the Trustees' accounts) for this period yielded a net income of \$24,864. This resulted from an SEYM total real income of \$132,724 against total expenses of \$107,860.

### SEYM General Fund for Administration - Cash Flow and Budget Performance

At the end of this period, the General Fund (the operations fund for which we approved a balanced budget of \$115,640 in our 2023 Yearly Meeting sessions) showed a net income of \$13,488. This resulted from General Fund total income of \$91,106 (79% of budget) against expenses of \$77,619 (67% of budget).

### **Budget Support Apportionments & Contributions Received**

During this period, in response to the annual request for support of the approved General Fund Budget (the Apportionments), contributions received from the Monthly Meetings and Worship Groups totaled \$72,847, or 71% of the year's budgeted request of \$103,175.

Fifteen Monthly Meetings and seven Worship Groups were included in the Apportionment request this fiscal year. So far, six (6) have contributed between 76% and 100% of their entire requested amount, five (5) have contributed between 51% and 75%, one (1) has contributed between 26% and 50%, one (1) has contributed between 1% and 25%, and nine (9) have not yet contributed anything.

The unrestricted individual donations received toward the Budget during this period totaled \$5,248, approximately 131% of the \$4,000 budgeted amount.

### Cash Flow Results for Programs

The annual programs for this fiscal year are in progress; cash flow is incomplete.

The Publications program during this period had a net real deficit of \$661, excluding unrealized capital gains of \$928 on investments for the program.

### Net Worth

The Net Worth of the combined Yearly Meeting and its Trustees at the end of this period was \$654,413, an increase of \$69,587 including \$40,235 in unrealized capital gains since the beginning of the fiscal year.

# Ad hoc Committee for Youth Coordinator Report and Proposal Southeastern Yearly Business Meeting 27 – 31 Third Month 2024

### Proposal for an SEYM Youth & Young Adult Coordinator position

SEYM will hire a Youth and Young Adult Coordinator (YYAC) to:

- Work with the Youth Committee to organize and coordinate events for youth, families, and young adults within SEYM, with a focus on building community, modeling and teaching our Quaker faith and values, and deepening the spiritual life of young adults and youth and their families.
- Reach out to families and young adults in SEYM Meetings and Worship Groups.
- Provide religious education resources and support to monthly meetings
- Help meetings conduct more inclusive and effective outreach to youth, young adults, and families

#### The Position

The YYAC position could be a 1/4- or 1/3-time job, depending on the responsibilities to be included. A 1/4-time job would cover the essential work of general organization and coordinating and being present at events. A 1/3 time job would include the events, plus being a resource person, with some limited time spent on pastoral care where needed. See Job Description (attached).

The YYAC position would offer an annual salary of between \$10,000 - \$16,000, depending on whether it is to be a 1/4-time or 1/3-time job; and based on the experience and skills the applicant brings to the job. As with other SEYM staff, there should be annual reviews, with merit and COLA pay increases.

The position is offered for a 3-year term, with continuation as approved by the Yearly Meeting.

There would be additional expenses besides salary to fully fund the position, such as for travel and expenses associated with in-person events.

A key element to the success of the YYAC would be having a support system within SEYM.

- 1. The position would be under the care of the Youth Committee and the Executive Committee. The Executive Committee would need to appoint a support committee for the YYAC for mutual accountability, communication, discernment, and encouragement. Committee members might be drawn from:
  - Youth Committee.: two members
  - Executive Committee: two members
  - CAPP Coordinator
- 2. Volunteers: an enthusiastic Youth Committee to work with, engaged young adults, parents, etc.

Additionally, the YYAC might have their own Anchor Committee related to their personal ministry and discernment.

### Qualifications

- A ministry or calling to work with youth and young adults.
- Background and experience in working with youth.
- Grounding in Quaker faith and practice and in the Quaker community.
- Passing background and reference checks.
- · Good communication and organizing skills

While SEYM would prefer that the YYAC live within the SEYM region, it is a possibility that they could live beyond SEYM; but in either case, they must be present at our Yearly Meeting Gathering, Half Yearly Meeting, and for two 3-day weekends during the summer for Family and Young Adult Retreats.

### Funding the position

The SEYM Trustees have agreed to the following arrangement for support of the YYAC position based on the premise that the future of SEYM does indeed lie with its youth:

- Trustees will contribute to support of the YYAC position for at least three fiscal years and agrees with including that support and the position's costs into future budgets as an SEYM staff position.
- 2. Trustees will transfer not more than \$20,000 in each of the relevant fiscal years from the Unrestricted Fund investments under its care to the SEYM General Fund Budget to support the YYAC position, starting with the first year of employment.

Additionally, Trustees request that the Yearly Meeting designate as a priority of its financial program the replenishment of the Unrestricted Fund after the time period of Trustees support of the YYAC position.

### YOUTH & YOUNG ADULT COORDINATOR DRAFT JOB DESCRIPTION

The SEYM Youth and Young Adult Coordinator (YYAC)

- Works with volunteers to organize and coordinate events for youth, families, and young adults within SEYM, with a focus on building community, modeling and teaching our Quaker faith and values, and deepening the spiritual life of young adults and youth and their families.
- Reaches out to families in SEYM Meetings and Worship Groups.
- Offers resources and support to SEYM Meetings and Worship Groups in welcoming families and building intergenerational community.

The YYAC works with the Youth Committee, SEYM staff, and volunteers.

This work could be a 1/4- or 1/3-time job, depending on the responsibilities included as agreed upon (see responsibilities, below). A 1/4-time job would cover the essential work of general organization and coordinating and being present at events. A 1/3-time job would include the events, plus being a resource person, with some limited time spent on pastoral care where needed.

The YYAC would be offered an annual salary of between \$10,000 - \$16,000, depending on whether it is to be a 1/4-time or 1/3-time job and based on the experience and skills the person brings to the job.

There are to be annual reviews, with merit and COLA increases in pay.

The position is under the care of the Youth Committee and the Executive Committee. The Executive Committee shall appoint a support committee for the YYAC for mutual accountability, communication, discernment, and encouragement. Committee members might be drawn from:

- Youth Committee: at least two members
- Executive Committee: at least two members, including a YM or IBM Clerk
- CAPP Coordinator

An Anchor Committee: the YYAC might have their own Anchor Committee related to their personal ministry and discernment.

### **General Organization & Communication**

Connecting people: "Youth, parents/caregivers, and young adults in SEYM have a deep hunger to connect with their peers in community."

- Families
- YAQs

### Statement on Conflict in Israel-Palestine

We are heartbroken by the terror, violence, and devastation in Israel and Palestine.

Our Quaker faith reminds us that there is that of God within every person, without exception. And that every person has the capacity to experience and respond to the love and guidance of God.

As a result, we unite with the calls of people across the world for:

- 1. a permanent ceasefire now,
- 2. immediate release of the hostages,
- 3. the provision of urgent humanitarian aid to Gaza,
- 4. and the creation of an independent sovereign state of Palestine beside the State of Israel.

We unconditionally oppose bigotry against Jews, Palestinians and other Arabs and Muslims that has led to the rise in hateful rhetoric and actions targeting these communities in the United States and worldwide.

The government of the United States has a responsibility — and an opportunity – to think with greater vision rather than contributing to the further militarizing of a tragic situation. We urge the President and Congress to join with other nations to address the roots of war and to work for a lasting solution that provides for security, justice, and dignity for all Palestinians and Israelis.

Our faith challenges us to resist the escalating pressures throughout our human family that attempt to justify atrocities against other human beings, and to remember that we are each capable of evil, even in the name of good. We take up the commitment to turn from our own hostile impulses, from amplifying division within our local communities, and from the cycles of vengeful action in conflicts worldwide, so we can move toward the courageous work of peacebuilding.

Let us seek paths to work for peace with the tools available to us. We are called to act in faith and love, with persistence, patience, and courage, as partners and hands of the divine spirit as we pursue the sacred goal of peace, shalom, salaam.

### St. Petersburg Monthly Meeting Southeastern Yearly Business Meeting 27 - 31 Third Month 2024

### Minute on Reproductive Rights

This minute by the St Petersburg Monthly Meeting (SPMM) ad hoc Committee on Reproductive Rights was approved by the SPMM Meeting for Worship with a Concern for Business on 5/21/23.

The members of the St. Petersburg Monthly Meeting of the Religious Society of Friends draw on our shared faith and practice in approving this minute as a testimony of our beliefs.

#### **Origin of our Opinion**

Through the testimonies and practice of our Quaker belief we respect the individuality of each person's spiritual journey, knowing that decisions can lead to both endings and beginnings, often in unexpected ways. The decision to have, or not have, children and the decision of whom to marry, or not marry, are examples of deeply personal, individual decisions to be made by the person or people involved, in the presence of Spirit.

#### Sanctity of Life

We acknowledge the sanctity of all life, honor and value the beauty of procreation. We recognize that an embryo's potential to thrive is wholly dependent on the support and nurturing of a biological or chosen family and of society. We seek to value this by addressing injustice, inequity, and coercion in society's present stance on reproductive health.

#### **Privacy of Health Decisions**

We affirm life by endorsing laws and policies that provide access to comprehensive reproductive medicine, including access to safe and legal abortion care, for women and families. We hold that the many-faceted impacts of both pregnancy and the termination of that pregnancy, including abortion care, is a profoundly personal health care decision which should be decided by a pregnant person in consultation with their doctor and their partner if they find it appropriate. We affirm life by respecting and protecting the inalienable right every human has to determine their individual role in human reproduction and family planning. We believe that no other rights of any government, group, or individual supersede this right.

#### **Immorality of Forced Pregnancy**

We come to this view by acknowledging the historical litany of suffering caused by forced procreation and its kindred injustice, outlawed procreation. These are dual horrors which have been wielded by persons and groups of certain classes, parties, races, sexes, and genders at various times and in various places to enforce their sometimes legal, yet always unequal and morally illegitimate, privileged status among their fellow humans.

#### **Education**

The discussion of women's reproductive health must be divorced from biased, politically motivated, misinformation. We call for medically accurate sex education for all ages on the safe practice and choices related to sexual behavior. Information relating to sex, contraception and termination of pregnancy (abortion) care must be easily accessible and delivered in a truthful, non-coercive environment without religious bias of any sort. It is vital to the well-being of our communities that quality and affordable medical care and comprehensive sex education should be available to everyone.

#### **Religious Liberty**

We support rights of conscience, freedom of religion, and separation of church and state. We value honest religious liberty which upholds the right of each person to make their own faith-based or conscience-based healthcare decisions. Each person should have opportunity for personal deliberation in accordance with their own moral codes, faith beliefs and consciences, and access to the level of care they believe is right for them. We reject any notion that religious, governing, or political bodies should have any say whatsoever in women's reproductive health decisions. Religious leaders and government officials have no business imposing their personal faith strictures or religious definitions of medical services into the laws of the land or the private lives of women and families. We protest the enshrinement of any faith strictures as public policy and disassociate ourselves from these restrictive voices.

#### Criminalization

We are opposed to recent federal and state legal actions which threaten the autonomy of pregnant peoples' bodies, and which criminalize their private, personal decisions. We should not be outlawing an individual's right to choose an abortion, which historically has led to many tragic cases of desperation and death. We reject the reasoning that would enable judges and legislatures to ban abortion and promote forced birth. We believe we should work to decriminalize any such decisions, and to preserve an individual's right and ability to carry out their decision.

#### **Parenthood Rights**

We believe that every child should be wanted, cared for and educated in a safe, healthy and loving, environment. Our society must share the responsibility of ensuring families and children realize their full potential and aid the termination a pregnancy if desired. In the case of non-consensual conception, sexual abuse, domestic violence, health concerns and even birthing situations where trauma is not present, the health and desire of the person giving birth is paramount.

#### **Future Ramifications**

As a religious organization that adheres to the testimony of equality, we believe that rights and equitable access to care must be available to all individuals and provided where their needs can best be met. An acceptance of all the variables in regard to sexuality and gender must be introduced at all levels of society so that the rights of all parents and their children may be respected. The current frenzy of exclusion which is marginalizing and demonizing non-heterosexual parents and their families must be reversed. We are opposed to any restrictions affecting same sex and transgender families.

#### Societal support

We seek a country with an equitable health care system that does not impose the greatest burdens on those least able to bear them. We must maintain and improve the physical and mental health of our population with affordable, equitable, and accessible healthcare that covers the entire life span, from family planning, contraception access, and prenatal care to end-of-life care.

All families must have equal opportunities to prosper. One of the most significant factors that lead to mental and physical health failure and the termination of pregnancies is poverty. Along with prioritizing public health services and affordable health care with robust federal support, we must target poverty, ensuring that policies regarding family must also include a living wage, paid family leave, affordable housing, affordable childcare, and high-quality public schools.

It is our belief that implementation of such measures will lead to a more affirming and nurturing society.

### Committee for Ministry on Racism (CMOR) Report Southeastern Yearly Business Meeting 27 – 31 Third Month 2024

Background and Recommended SEYM Minute on Donation to the California Heritage: Indigenous Research Program (CHIRP)

The Committee for Ministry on Racism supports SEYM giving a donation to the Tribally-led, California nonprofit California Heritage: Indigenous Research Program (CHIRP), which is raising money to make possible the sale of Sierra Friends Center to the Nevada City Rancheria Nisenan Tribe so that their ancestral land, Yulica, can be returned to them. A donor has offered to match all gifts up to 100,000.00 through March 31, 2024. A sale is needed because of costs Sierra Friends Center must meet. Owning their land may also aid in the Tribe's efforts to once again be recognized by the federal government, which will make it possible for them to have many of their other needs met.

Background summarized by Quaker Earthcare Witness (QEW) <a href="https://quakerearthcare.org">https://quakerearthcare.org</a>:

Santa Cruz Friends Meeting is calling all Quaker Meetings in the U.S. to participate spiritually and financially in an historic Quaker moment: <u>Homeland Return</u> of the Sierra Friends Center (Woolman) to the Nevada City Rancheria Nisenan Tribe.

The board of the Sierra Friends Center (formally, College Park Friends Educational Association, CPFEA) has entered into a purchase agreement with the Nevada City Rancheria Nisenan Tribe through the Tribally-led California nonprofit, California Heritage: Indigenous Research Program (CHIRP). The Tribe has not had land since 1964 when the Federal Government illegally terminated the Nevada City Rancheria Nisenan Tribe and sold their reservation at auction. This is the Tribe's best opportunity to re-establish a tribal homeland and may support their efforts toward Federal re-recognition.

The land that Sierra Friends Center has operated from is the site of an ancestral Nisenan village called Yulića. These 232 acres, as well as the surrounding land known as "Nevada City, California", were taken from Indigenous peoples during the Gold Rush and sold to settlers who were colonizing the area. A group of Quakers purchased the land in the 1960s for educational programs.

The Sierra Friends Center nonprofit, originally under the care of College Park Quarterly Meeting, was created to operate the school programs and manage the property. The Center ran the John Woolman boarding school, which operated from 1963-2001, followed by the Woolman Semester school, which operated from 2004-2016. The Center also operated outdoor education programs as well as a summer camp rooted in Quaker faith and practice.

The Sierra Friends Center board's journey is chronicled in detail on the Woolman at Sierra Friends Center website. The Tribe now has a time-limited opportunity to purchase the property. The agreed-upon price includes the purchase price, government-mandated improvements, and an operating endowment. The overall fundraising goal is \$2.4 million; the first phase of this effort, to raise \$1.5 million, closes on April 4, 2024. CHIRP launched a GoFundMe campaign at the end of January, which has already reached \$853,662 with over 1300 individual donors, including Quakers.

As Quakers, we believe that supporting this process both spiritually and financially is a living example of our Stewardship testimony and our legacy as activists. It is our faith in action. It creates healing from a moment of loss. It is restorative and it is ethical. It feels important to do all we can to support the Tribe.

Following the Light that revealed the harms done to the Nevada City Rancheria Nisenan Tribe in the above background summarized by Quaker Earthcare Witness (QEW), and in responding in solidarity to the call from Santa Cruz Friends Meeting to Quakers to donate to the California Heritage: Indigenous Research Program, the Committee for Ministry on Racism recommends that Southeastern Yearly Meeting approve the following minute:

Southeastern Yearly Meeting of the Religious Society of Friends approves a 500.00 donation by check to the California Heritage: Indigenous Research Program (CHIRP), the nonprofit raising funds to purchase the Sierra Friends Center in order to return to the Nevada City Rancheria Nisenan Tribe, their ancestral land, Yulica. We encourage individual Friends, Meetings, and Worship Groups to donate also as led. We are grateful to the Santa Cruz Friends Meeting for alerting Quakers to this opportunity to help redress inhumane wrongs done to the Tribe by the state and federal governments from which Quakers were among the beneficiaries. We will inform the clerks of Santa Cruz Friends Meeting, Hans Brinker and Nancy Wood, of our donation.



#### **Report to Yearly Meetings**

Spring 2024

Dear Friends,

Our Quaker faith and practice call us to bring into being the world we seek. Since 1943, the Friends Committee on National Legislation has carried on this witness of the Spirit through national advocacy. Your engagement, financial contributions, and spiritual support make this work possible.

#### Pursuing Peace with Justice in an Uncertain World

FCNL seeks peace, justice, and an earth restored by advocating for federal policy change in the areas identified by Friends through our bi-annual priorities setting process. Priorities for the 118<sup>th</sup> Congress are at *http://fcnl.org/priorities* Updates on these and other issues are at *http://fcnl.org/issues* 

Ceasefire Now in Israel and Palestine. FCNL has been advocating for a ceasefire since the October 7, 2023 Hamas attacks, condemning both Hamas's violence and Israel's indiscriminate response. Working in concert with more than 80 other organizations, our network has taken more than 500,000 actions to lobby, demonstrate, and minute their concerns. A February 2024 *New York Times* article highlighted FCNL's efforts to counter political spending with "people power" to support a ceasefire, de-escalation, and humanitarian aid in Gaza.

Help Millions of Children Escape Poverty. At the height of the pandemic, Congress expanded the Child Tax Credit, reducing child poverty by more than 40 percent. Since that legislation expired, child poverty in the U.S. has rebounded to high levels. FCNL is integral to lobbying efforts to revive the expanded Child Tax Credit, with the potential to help 16 million children. The Tax Relief for American Families and Workers Act (H.R. 7024) passed the House in early 2024 and moves to the Senate, where our advocacy continues.

**Heal the Harms of Nuclear Testing.** FCNL has partnered with communities most affected by U.S. nuclear testing to advocate for an extended and expanded Radiation Exposure Compensation Act (RECA). Congress needs to act before the RECA program expires in 2024.

**Support Truth and Healing on Indian Boarding Schools.** FCNL is supporting the formation of a formal commission to investigate the horrific past and impact of the 367 federally sponsored, institutions run by religious groups that existed until the 1960s. At our 2024 Spring Lobby Weekend, more than 300 young adults lobbied for passage of the Truth and Healing Act.

#### **Nationwide Advocacy & Radical Hospitality**

Our conviction that there is that of God in every person leads us to advance this work through a focus on relationship: among advocates, Friends, and FCNL staff, and with decision-makers. We foster a community that can engage amid conflict, uplift each other, and find creative ways to make change in the face of the many crises in our world.

Our network of knowledgeable, passionate advocates live in all corners of the country. We now have more than 130 Advocacy Teams across 47 states. Our 2023 campaign focused on investing in conflict and atrocities prevention programs. The Teams' efforts culminated at November's Quaker Public Policy Institute, where participants logged more than 120 lobby visits in two days. In 2024, Teams are lobbying for reductions in Pentagon spending. See https://www.fcnl.org/act/join-advocacy-team

Friends Place on Capitol Hill. This guest house and hospitality center on Capitol Hill hosted 94 groups, totaling 1,758 guests, between July 2022 and June 2023. This total includes more than 400 migrants bussed from the southern border, whom FCNL hosted as a partner of the Migrant Solidarity Mutual Aid Network. Friends Place also anchors FCNL's engagement with the D.C. community and offers advocacy programming. More at http://friendsplacedc.org

#### Charting a Course Toward the World We Seek

Creating the world we seek begins with our own transformation. As FCNL builds its influence on national policy, we also focus on the patterns and practices of our own community. Our new strategic plan for 2024-2028 focuses in both areas. It calls on FCNL to strengthen its nonpartisan influence as a leading faith advocacy organization, foster beloved community, engage new people in advocacy work, and become better equipped to meet the challenges ahead. A key part of this plan is the continued **integration of anti-racism**, **anti-bias**, **justice**, **diversity**, equity, and inclusion (AJEDI) into our work. We are building skills and structures for listening, clearness, and restorative practices to embed these principles throughout FCNL. This work allows us to better align the experience of people in our community with the values we hold.

These efforts are, as always, guided by Spirit and by the leadings of you and others who give of their time, resources, and talent. The spiritual depth of this work was evident in the year-long process of developing new policy guidance around reproductive health care and abortion (see https://www.fcnl.org/ReproductiveHealthPolicy). Abortion had been named as a "challenge" to Friends that FCNL took no position on. More than 300 Friends meetings, churches, and other groups gave input, representing many perspectives. The revised statement names differences among Quakers, supports individual choice and equitable access for healthcare decisions, recognizes the sanctity of human life, and opposes the criminalization of abortion services.

### Youth & Young Adult Coordinator Report & Proposal (Amended) Southeastern Yearly Business Meeting 27 - 31 Third Month 2024

Approved at Yearly Business Meeting 2024

SEYM will hire a Youth and Young Adult Coordinator (YYAC) to:

- Work with the Youth Committee to organize and coordinate events for youth, families, and young adults within SEYM, with a focus on building community, modeling and teaching our Quaker faith and values, and deepening the spiritual life of young adults and youth and their families.
- Reach out to families and young adults in SEYM Meetings and Worship Groups.
- Provide religious education resources and support to monthly meetings
- Help meetings conduct more inclusive and effective outreach to youth, young adults, and families

#### The Position

The YYAC position is to be a 1/2-time job. (See Job Description below.) The position would pay \$24,000 per 12-month period.

Additional benefits might be found in the form of offers of housing or a car.

As with other SEYM staff, there should be annual reviews, with merit and COLA pay increases.

The position is offered for a 3-year term, with continuation as approved by the Yearly Meeting.

#### **Support**

A key element to the success of the YYAC would be having a support system within SEYM.

- 1. The position would be under the care of the Youth Committee and the Executive Committee. The Executive Committee would need to appoint a support committee for the YYAC for mutual accountability, communication, discernment, and encouragement. Committee members might be drawn from:
  - Youth Committee.: two members
  - Executive Committee: two members
  - CAPP Coordinator
- 2. Volunteers: a strong Youth Committee to work with, engaged young adults, and enthusiasm in Monthly Meetings and Worship Groups to work to provide welcoming spaces for families and young adults.

Additionally, the YYAC might have their own Anchor Committee related to their personal ministry and discernment.

#### Funding the position

There would be additional expenses besides salary to fully fund the position, such as for payroll taxes, travel, and other expenses associated with in-person events.

The total budget to fund the position would be \$30K per year.

#### **Fundraising**

SEYM commits to do fundraising to provide the additional \$10 per year needed to fully fund this position.

#### **Search Committee**

Upon approving this proposal, SEYM needs to appoint a Search Committee made up of 3 Friends, to begin their work at rise of this Yearly Meeting. Kathy Hersh has agreed to serve.

#### Qualifications

- A ministry or calling to work with youth and young adults.
- Background and experience in working with youth.
- Grounding in Quaker faith and practice and in the Quaker community.
- Passing background and reference checks.
- Good communication and organizing skills

While SEYM would prefer that the YYAC live within the SEYM region, it is a possibility that they could live beyond SEYM; but in either case, they must be present at our Yearly Meeting Gathering, Half Yearly Meeting, and for two 3-day weekends during the summer for Family and Young Adult Retreats.

#### YYAC JOB DESCRIPTION

The SEYM Youth and Young Adult Coordinator (YYAC)

- Works with volunteers to organize and coordinate events for youth, families, and young adults within SEYM, with a focus on building community, modeling and teaching our Quaker faith and values, and deepening the spiritual life of young adults and youth and their families.
- Reaches out to families in SEYM Meetings and Worship Groups.
- Offers resources and support to SEYM Meetings and Worship Groups in welcoming families and building intergenerational community.

The position is under the care of the Youth Committee and the Executive Committee. The Executive Committee shall appoint a support committee for the YYAC for mutual accountability, communication, discernment, and encouragement. Committee members might be drawn from:

- Youth Committee at least two members
- Executive Committee at least two members, including a YM or IBM Clerk
- CAPP Coordinator

An Anchor Committee: the YYAC might have their own Anchor Committee related to their personal ministry and discernment.

#### Suggested Workshop/Event Topics

- Angelic Troublemaking: Beyond Bystander Training explores anti-racism/decolonization work with emphasis on local concerns and means of accompaniment;
- Climate Equity/Climate Justice in Our Community: identifies specific local social justice and equity concerns. Participants identify actions to address concerns;
- Decolonizing Earthcare: explores the intersectionality of gender, race, extraction, and harmful economic systems and the adverse impacts to the Earth.
- Discerning Earthcare Leadings: listening and sharing experiences to reach individual and group decisions on Earthcare actions;
- Earthcare audits: baseline assessment of individual or community activities and discernment;
- Equality or Equity? What is Our Testimony?: examines Friends' equality testimony, the concepts of equity and justice, and the relationship of these to Earthcare;
- Permaculture is Not Just Agriculture: introduces permaculture design and domains and ways to bring these practices into Earthcare;
- Project Drawdown, Introduction and more: presents information on actions that "drawdown" carbon emissions and ways to promote drawdown choices as individuals and communities:
- Quakers and Climate Collapse: shares and builds on a Woodbrooke course led by Jackie Carpenter from 2021 Fifth Month (May), including review of the latest science, worship sharing, and discernment.
  - o I also can build on my Pendle Hill presentation to help with local concerns;

- Racial Wealth Gap Simulation: an exercise that helps "...people understand the connections among racial equity, hunger, poverty, and wealth";
- Transportation, migration, and climate: explores access and mobility issues from the local to global perspective and the impacts of climate change;
- Underwater Homeowners Association: shares local actions that can be undertaken by communities experiencing sea level rise;
- Water: Sea Level Rise, Flooding, and Water Quality explores local, national, and global water issues;
- Waterline Communities: Displacement and Gentrification and Why Quakers Should Care drills down to the county or community level on the impacts of displacement; and
- What the Infrastructure Investment and Jobs AND Inflation Reduction Acts Mean to Me and My Community? This workshop looks at how funds from the two acts are being dispersed at the local level and provides suggestions on how to get involved in the decisionmaking process. Special emphasis is given to working with local implementing agencies and collaborating with advocacy groups to address adverse climate and environmental impacts.

#### Interactions or Collaborations between and among other SEYM committees

These interactions between and among SEYM committees help to facilitate communication and collaboration of our regional concerns with national organizations and to be a Quaker Presence at specific events.

- The Committee for Ministry on Racism (CMOR): In addition to supporting the work of CMOR for annual gatherings, I act as a liaison to committee and the wider Quaker World and other organizations promoting equity. This includes work with, but not limited to, Decolonizing Quakers; Quaker Earthcare Witness; Quakers Uprooting Racism; and Toward Right Relationship with Native Peoples.
- Earthcare Committee: In addition to facilitating a workshop during the 2024 SEYM Annual Gathering, "A Friendly Guide to Perma[nent] Culture", special efforts are

- underway to engage members of the SEYM Earthcare Committee and others to help with the SEYM Community Preparedness planning.
- Florida Council of Churches (FCC): John Heimburg and I participated in the Florida Council of Churches 2024 Advocacy Days during the Florida legislative session. This included training on issues and legislative meetings on 29 First Month (January) at the Florida People's Advocacy Center and an Interfaith Service for Harmony and Healing at First Presbyterian Church later that evening. On 30 First Month, we committee appearances and visited legislative offices. We shared SEYM's 22YBM05 Minute on the Anti-Gay and Anti-Woke Legislation with a number of elected officials and their staff. Below is a photograph of some of the FCC delegation.

Please continue to hold the Council in your hearts due to the challenges mentioned in the Fall Interim Business meeting report, I am serving as interim secretary to FCC through Fifth Month;

- Half Yearly Meeting (HYM) Committee: As an ex-officio member of the HYM committee, I continue to participate in planning activities. Kathy Hersh and I will work the administrative secretary and the website clerk to make the HYM guide available online. I also consult with the Youth Committee on other events, e.g., annual gathering.
- Peace and Social Concerns (P&SC) Committees: I continue to meet with or otherwise support the Yearly and Monthly Meeting PSC committees. Most recently, I have agreed to provide support to the Yearly Meeting P&SC Committee incoming co-clerks. This will include, but is not limited to, information on the environmental

- impacts of militarization and wars and the adverse impacts of rapidly rising ocean temperatures;
- Quaker United Nations Office (QUNO), AFSC: Bill Carlie and I now share SEYM
  appointments to AFSC. I am an AFSC representative on the Quaker United Nations
  Committee (QUNC). I will participate virtually in the upcoming Fourth Month
  meeting of QUNC;
- Right Sharing of World Resources: I continue to share information through the-QEW United Nations Working Group, AFSC, and Quaker United Nations Committee
- Youth Committee: I continue to work with the Youth Committee. Special efforts will be made to include youth in the development of the preparedness guidance.

#### The Wider Quaker World, Interfaith Groups, Other Environmental Organizations

To communicate and collaborate our regional concerns with national organizations including Quaker Earthcare Witness (QEW), Earth Quaker Action Team (EQAT), Friends Committee on National Legislation (FCNL), and Friends General Conference (FGC). To be a Quaker Presence at specific events, including those arranged by others.

I continue to work with the wider Quaker World, interfaith groups, and environmental organizations. These interactions have been virtual and in person during this period.

- Alternatives to Violence Project (AVP): I am working with Kathy Hersh to plan AVP workshops with Volusia County youths who are on parole in the judicial system. Members of Quakers of Orlando also have expressed interest in AVP workshops. The planning is underway.
- American Friends Service Committee (AFSC): I continue to serve as a corporate member of AFSC, QUNC and AFSC's Third World Coalition.
- Decolonizing Quakers, <a href="https://www.decolonizingquakers.org/">https://www.decolonizingquakers.org/</a>: The Indigenous and Friends of African descent affinity groups continue discernment on the meaning of "decolonizing". Representation of Friends of African descent is increasing;
- Earth Ethics Institute (EEI), <a href="http://earthethicsinstitute.org/">http://earthethicsinstitute.org/</a>, Miami Dade College: In addition to the presentation, "Climate Change and Earth Literacy" during the 2023-24 Campus Learning Community Earth Literacy & Changemaking Symposium, the EEI advisory board is planning a meeting in Miami. I am looking forward to "feeding at least two birds with one scone" as Brad Stoker would say by participating in the advisory group meeting and visiting Miami Meeting!;
- Fellowship of Friends of African Descent (FOFAD): the work of Decolonizing Quakers overlaps with the FOFAD activities, the Black Quaker Project, <a href="https://www.theblackquakerproject.org/">https://www.theblackquakerproject.org/</a>, and Quaker Earthcare Witness (QEW);
- Florida Interfaith Climate Actions Network (FL-iCAN): Jan Booher continues to work with the Florida Disaster Resilience Initiative, (<a href="https://resiliencesystem.org/dashboards/florida-disaster-resilience-initiative/">https://resiliencesystem.org/dashboards/florida-disaster-resilience-initiative/</a>) and share health and environmental information, including COVID-19. The Florida Council of Churches is planning to resume convening FL-iCAN assemblies;
- Friends Committee on National Legislation (FCNL): Brad Stocker and I continue to share a slot as representatives to FCNL for QEW. Through the QEW, I have partici-

- pated in discernment of a number of legislative issues, e.g., reproductive rights, armed conflict, etc..
- Friends General Conference (FGC): I continue to work with FGC, particularly with the Fellowship of Friends of Color, FOFAD, and Quakers Uprooting Racism. The proposal that John Heimburg and I submitted for the 2024 Gathering workshop, "Bring Your WholeSelf" has been accepted. We are busy developing course material, promoting, and otherwise preparing for the workshop. Hold us in your hearts!
- Friends Peace Teams (FPT): I continue to work with members of FPT and link FPT to QEW UN Working Group and Towards Right Relationship/Decolonizing Quakers. With the new FPT North America Regional Team, we are in discernment on livable wages and equity;
- Friends United Meeting (FUM): I continue to work with Jim Kessler, Grinnell Friends Church, through Quaker Earthcare Witness;
- Friends World Committee for Consultation (FWCC): I continue to work to strengthen links to FWCC through QEW, FGC, and AFSC;
- National Academies of Sciences, Transportation Research Board (TRB), Equity in Transportation and the Women's Issues in Transportation Committees. I continue to work with these committees and to serve on the planning committee for the 2024 Conference on Advancing Transportation Equity which will be convened 15-18 Seventh Month (July) 2024 in Baltimore, MD.
- Nurturing Faithfulness (NF) program, I was invited by Marcelle Martin and Jennifer Hogue to be interviewed about Earthcare work, climate justice, environmental witness, and other ways of helping communities to prepare for the changing times to come. (NF is a collaboration between New England Yearly Meeting, Woolman Hill, Hilary Burgin and Marcelle Martin.) The recording is being prepared for distribution and will be shared with SEYM. Stay tuned!

# A Reading from the United Nations Resolution for World Interfaith Harmony Week, 23 Eleventh Month (November) 2010

This is followed by prayers for peace from the Baha'i, Buddhist, Christian, Hindu, Jewish, Muslim, Native American, and Sikh faith groups.

# Southeastern Yearly Meeting Quakers in Florida, southeast Georgia & South Carolina

### Yearly Gathering 27 - 31 Third Month 2024

## **Epistle**

Dearest Friends,

Ninety-five of us, including nine youth and two wee Friends, gathered at the DaySpring Episcopal Conference Center in Parrish, Florida, while fourteen joined online. This was the 60th gathering of the Southeastern Yearly Meeting.

Over the next four days we worshiped, and workshopped, laughed, and loved and did the Meeting's business. There was some heavy rain at first, but soon the skies cleared and the spring weather turned balmy. The trees were in full leaf, herons and swallowtail kites soared overhead; doves cooed in the mornings; the hospitality of the Conference Center staff was warm and welcoming. Minor challenges were overcome; representatives of Quaker organizations shared their materials; old acquaintances were lovingly renewed; new affinities were discovered, bold initiatives were undertaken—or at least referred for continuing, hopeful discernment. At the end of the gathering, we could all agree that the Southeastern Yearly Meeting will carry on speaking truth and faith through another year in these turbulent times.

The theme of this year was The Friends we are becoming: embracing our longings & leadings. We were joined by representatives from American Friends Service Committee, Friends Committee on National Legislation, Friends General Conference, Quaker House, Quaker Voluntary Service, and Right Sharing of World Resources. Members and visiting representatives led us through workshops on the spiritual journey, immigrant rights, supporting trans life, living our Quaker faith LOUDLY, individual spiritual discernment, right balance in our use of things, cultural differences and racism, and personal spiritual narratives. Morning worshipers greeted the sunrise in reverent silence. Evening activities combined dancing and talent shows with videos and lectures on Quaker concerns.

The Meeting's plenary sessions received reports and considered weighty topics. Of particular concern was the ongoing wars in Gaza, Israel and Palestine, and Ukraine. Friends expressed concern for all victims of war. We were deeply affected by the violence in Gaza and heard reports from monthly meetings that made public statements calling for a permanent cease fire. Diminished attendance in monthly meetings is an abiding concern and Friends spoke urgently about the need for better coordination of youth programs and outreach to the wider community.

The SEYM Quaker Call Committee addressed pain SEYM Quakers are feeling from the brutal, heartless, and relentless assault upon our core values made by the current governmental administration in Florida and beyond. It is seeking a way of uniting SEYM Quakers behind a project or projects that will actively, but non-violently, respond to that assault by turning its own energy against itself, or by being a "pattern or example" of a better alternative than that which has been

chosen by the State of Florida. We are urged to accept responsibility for getting ourselves into physical, mental, and spiritual shape, in order to engage effectively in what increasingly feels like a direct spiritual conflict; to discern, accept, and fulfill the urgent call of the Spirit to live our spirituality clearly, proudly, and loudly, in order that we can respond to the Spirit in others, and they can respond to the Spirit in us.

The Walton Lecture and Retreats came to us from Hilary Burgin of Quaker Voluntary Service. Hilary gave us the marvelous analogy of Truth as a fractal pattern. In times of trouble, it can be difficult to find the divine, but we can always access something of the truth and find way forward. Focus on process, she encouraged us, not on outcomes. "We create what we are by doing the next thing next."

Amy Richards captured the spirit of our gathering with a poem:

Battle weary heart despairing Grief clouds in war worn caring Yet love remains In laughter of Friends of old and jesting banter Popcorn singing dancing mirth Renew our soul in new spring birth Another day Another year Hope remains amidst the fear Fear the dance business Bringing the steps well-known It feels so good to finally be home. The work continues while Grace abounds A soft sweet voice that Joy has found. It is not lost as once was found Just in the arms of Friends so dear Stand fast threshing motions passing A budget balanced

We depart in loving fellowship, glad in each other and our Quaker faith.
