# Specially Called Executive Committee Meeting 17 Fourth Month 2024

## **MINUTES**

Friends gathered in worship at the appointed hour.

Bill Carlie opened from the silence with a reading from George Fox:

I was shown that my words should be few, savory, and seasoned with grace.

This Executive Committee meeting was called to determine our response to notice that SEYM (along with Gainesville Friends Meeting and Central Florida College) was named a beneficiary of the residual estate of Georgia Guin, a member of Gainesville Friends Meeting. The will has been challenged by members of the family. We have a limited time frame in which to respond. We must engage an attorney to respond to the challenge to invalidate the will.

Dan Vaughen summarized the actions taken to date. He attempted to contact several lawyers but didn't get a response. Lewis Kirvan contacted Nick Harvey, who is willing to represent SEYM and Gainesville Friends Meeting. He would require a refundable retainer of perhaps \$5000. A refundable retainer guarantees that the parties are serious and going to follow through on the case. The Central Florida College has hired counsel to defend their share in the case. We need to make an initial response by Friday.

Gainesville Friends Meeting (GFM), at its business meeting on First Day, 14 April 2024, minuted that it would initially put up \$1500 towards attorney's fees, and with having the Finance Committee with the meeting clerk making decisions going forward when time is of the essence.
