Ad hoc Committee For Addressing Sex Offenders In The Yearly Meeting Report 2025 Summer Executive Committee Meeting 21 Sixth Month 2025

Two years ago, at annual gathering an *ad hoc* committee was formed to create a policy/ procedure for addressing sex offenders at the yearly meeting. Bill Carlie, Jan Dahm, Rachel Dillinger, Sharon Dwyer, Sara Weatherby and Cheryl Demers-Holton, met weekly for five weeks to create a comprehensive policy that covered how the yearly meeting would address: discovering that a sex offender has been at a meeting, that a registered sex offender wishes to attend a yearly meeting event, and what to do if there is suspicion at a yearly meeting event.

This committee was instructed to create a policy that not only protected children but also attended to the reality that there are vulnerable adults in our midst. Over a year ago Orlando Monthly Meeting worked on a risk management policy for their monthly meeting, a few of the people on Orlando's *ad hoc* committee had been involved in SEYM's committee. With Orlando Monthly Meetings approval, we used their policy as a template for the yearly meeting's policy.

Our *ad hoc* committee offers the attached document for approval by the executive committee, to be included in the SEYM document handbook. The committee also recommends that sections V, VI, and VII, of this document be added as an addendum to SEYM's Child Abuse Protection and Prevention Training Manual.

If this document is approved, we ask that this *ad hoc* committee be laid down.

**Southeastern Yearly Meeting Risk Management Policy and Procedures
Related to Sexual Offenses**

I. Preamble:

Southeastern Yearly Meeting of the Religious Society of Friends (SEYM) is a diverse, welcoming, nurturing, and inclusive community of people who support each other in spiritual growth. It is our desire both to welcome all seekers interested in following the Quaker way and to be a safe space for all who attend our meeting, with a special concern for the children and vulnerable adults in our care.

II. Recognition and Notice of Risk:

As of February 2024, there are nearly 700,000 registered sex offenders in the United States. Over sixty percent of convicted sex offenders are under some form of community supervision and living within their local communities. SEYM is an open and welcoming Yearly Meeting, so there may be known and unknown sexual offenders attending Annual Gathering, Interim Business Meetings, and other SEYM sponsored events.

It is not the practice of SEYM to do any sort of background check or sexual offender screening of attenders to annual gathering or other events. However, members, attenders, and staff who work with children are subject to the background check procedures outlined in the current Child Abuse Protection and Prevention (CAPP) Manual. **This was approved by _____**. The Yearly Meeting will post the following notice in the Safety section of the SEYM website:

Southeastern Yearly Meeting takes the safety of all our attenders very seriously. If you suspect that anyone attending our meeting might be a victim of abuse, please notify the Florida Abuse Hotline at 800-962-2873. Then notify the Clerk at ymclerk@seymquakers.org.

A copy of our Risk Management Policy and Procedures Related to Sexual Offenses can be found online at SEYM.org or can be obtained from the Clerk.

III. Protection of Children and Youth:

The CAPP Manual contains detailed procedures for the protection of children and youth from sexual and other offenses while they are in the care of the Yearly Meeting. These procedures include, but are not limited to:

A. background checks on all members, attenders, vendors, and staff who are expected to work independently with children and youth during SEYM activities.

B. a formal application and reference process for recruitment and selection of paid childcare staff and volunteers.

C. consistent supervision of children and youth by at least one CAPP registered adult and one other responsible and appropriate adult during scheduled activities.

Additionally, volunteers will be encouraged, and paid staff will be required, to participate in the SEYM Child Abuse Prevention Training. The Youth Committee with the youth and young adult (YYA) coordinator is responsible for implementing these procedures, for regular review of the CAPP Manual, and for obtaining the support and approval of the Yearly Meeting as a whole. All officers, members, and attenders of the Meeting will also be encouraged to participate in training and discussions that increase awareness of the risks and impacts of sexual offenses on individuals throughout their lifespan.

IV. Response to Allegations of Abuse During Meeting Activities:

The Yearly Meeting follows the legal requirements detailed in the Florida Department of Children and Families publication “Reporting Abuse of Children and Vulnerable Adults” available at: Abuse Hotline | Florida DCF (myflfamilies.com). Florida Statute 39.201(1) requires any individual who suspects that a child has been abused by any person to report that to the Florida Abuse Hotline. When an incident of abuse or neglect is alleged to have occurred at a Yearly Meeting function, the appropriate persons will follow the procedures below:

- A. The person who suspects abuse will document and report their observations as required by law. After reporting, they will report their observations to the Clerk of the Yearly Meeting.
- B. The YYA Coordinator and/or the Clerk of the Yearly Meeting will notify the parent or guardian of the child or vulnerable adult. The Monthly Meeting of the perpetrator will also be notified.
- C. The YYA Coordinator and/or the Clerk of the Yearly Meeting will immediately place the person alleged to be the perpetrator of the misconduct on leave from contact with children and vulnerable adults in the Meeting pending an investigation and instruct the person to remain away from the Meeting during the investigation. If the accusation is substantiated, the alleged perpetrator will be treated as a registered sex offender for the purposes of this policy.
- D. The YYA Coordinator and/or the Clerk of the Yearly Meeting will make a report to the Florida Abuse Hotline. The Yearly Meeting will fully cooperate with the investigation by the Child Protective Services, Law Enforcement, and other civil authorities.
- E. The YYA Coordinator and/or the Clerk of the Yearly Meeting will notify the insurance company about the occurrence and will complete an incident report and immediately forward any documents relating to the allegations to the insurance company.
- F. The Clerk of the Yearly Meeting will be the sole spokesperson to speak on behalf of SEYM to the media concerning incidents of alleged abuse or neglect, unless they are alleged to be involved, in which case the designated spokesperson of the Meeting will take on this responsibility. The Clerk of the Yearly Meeting may seek the advice of legal counsel before responding to media inquiries or releasing information to the Meeting as a whole. All other members and attenders of the Meeting will be requested to refrain from speaking to the media.
- G. The Clerk of the Yearly Meeting or designee, under the advice of legal counsel when appropriate, will also be the sole spokesperson to speak on behalf of SEYM to law enforcement, insurance representatives, and other legitimately interested parties. This in no way interferes with the responsibility of individual members and attenders to cooperate with law enforcement during the investigation of an alleged crime.
- H. The SEYM Worship and Ministry Committee will be available for pastoral visits as requested.

V. Response to the Presence of a Registered Sex Offender:

When a concern arises about an individual attending any SEYM function being a convicted sex offender, anyone holding that concern can check the United States Department of Justice National Sex Offender Public Website (nsopw.gov) for verification. This site contains current nationwide public records for persons who are convicted sex offenders and required to register as such in the communities where they reside.

When the Clerk of the Yearly Meeting or the YYA Coordinator become aware of a sexual offender attending an SEYM event who has not followed the procedures outlined in section VI of this document, the following steps will be taken by the Clerk of the Yearly Meeting, the YYA Coordinator, the CAPP Coordinator and/or appropriate, designated members, attenders, and staff:

- A. Verify via an appropriate legal resource that there are no current federal, state, or local laws prohibiting the attendance of this individual at SEYM events where children and vulnerable adults may be present.
- B. Alert SEYM members and attenders that a registered sexual offender has attended one or more SEYM activities. This notice will be placed in the next published edition of SEYM eNews and announced at the next scheduled Meeting for Worship with Attention to Business. The alert will not contain identifying information such as name or address. The alert will provide the Clerk's email for those who would like to request more information. The alert will also provide the wording: "As always, the Worship and Ministry Committee is available to listen to anyone who wishes to have a confidential talk with the committee or a member of the committee in relation to this policy."
- C. The SEYM Clerk, accompanied by another member, will instruct the sexual offender to cease attending all meeting activities in person and online until an individual plan of care can be developed.
- D. The SEYM Clerk will send the offender back to their monthly meeting to develop a Plan of Care for a Registered Sex Offender. If the Monthly Meeting has not developed their own policy for addressing a registered sex offender that wishes to attend a Monthly Meeting, then the Yearly Meeting suggest they use Orlando's policy as a guide.

Attach Orlando Policy

VI. Plan of Care for the Presence of a Registered Sexual Offender During SEYM Scheduled Online or In-Person Activities:

If a registered sex offender (RSO) wishes to participate in a Yearly Meeting function:

- A. They must have a Plan of Care developed at the Monthly Meeting and have followed that plan with integrity for a minimum of one year. The RSO's oversight committee must be in unity that this person should be allowed to attend.
- B. The RSO will notify the Clerk, YYA Coordinator or CAPP Coordinator of their desire to attend a Yearly Meeting function two weeks in advance of the opening of registration.
- C. The RSO must send a written copy of the Plan of Care to the Clerk and Coordinators for review in advance of the event.
- D. The RSO must arrange for two responsible adults, preferably from their oversight committee, to attend the event with them. The responsible adults will work together to assure the RSO is in the company of one or the other 24/7 during the event.

- E. The plan of care including the names of the responsible adults will be reviewed by the Clerk, the YYA Coordinator and the CAPP Coordinator to assure that the plan and responsible people are sufficient to assure the safety of all attending the Yearly Meeting event.
- F. The Clerk and Coordinators are confident of the safety of the plan, they will meet with the RSO and review any additions to the care plan. At a minimum this review will include:
 - a. Limit the individual's access to any property hosting SEYM events to times when two or more responsible adults (preferably both from the oversight committee but definitely at least one committee member and one other responsible adult) other than the offender are present.
 - b. Prohibit access to any room or building that has been set aside for exclusive use for children or vulnerable adults.
 - c. Follow the existing approved written policies and procedures found in the CAPP Manual for supervision and protection of the children who participate in programs at SEYM.
 - d. The RSO will be notified that the Assistant Clerk, the Clerk of Worship and Ministry, the youth workers and the parents of all children will be notified that a RSO will be attending the Yearly Meeting and that they have a Safety Care Plan that has been reviewed by the SEYM Clerk and Coordinators. And if any of those people ask for the name of this person or wish to see the written Care Plan, they will be given that information as well. This notification will be made in advance of each Yearly Meeting event the RSO wishes to attend.

VII. Plan of Care for the Presence of a Registered Sexual Offender (RSO) During SEYM Scheduled Online Activities:

An RSO with an established plan of care may attend an SEYM online activity so long as the activity is not explicitly intended for children and the RSO does the following:

- A. registers for the activity as soon as possible after registration opens
- B. provides the organizer with their plan of care upon registration
- C. receives approval from the event organizer and the SEYM clerk
- D. leaves their camera on during the entire activity
- E. uses the chat function only to send messages that are visible to the entire group, not just specific individuals

For recurring online activities such as weekly worship, the RSO must only seek approval the first time they attend. However, they must still notify the organizer via email each subsequent time they plan to be there. Parents of any youth registered will be notified as described for in-person activities above.

If at any time during any SEYM event the RSO does not choose to or is unable to follow their approved Care Plan, they will be asked to leave immediately by the SEYM Clerk, the YYA Coordinator or the event organizer.

The CAPP Coordinator and YYA Coordinator will organize an educational opportunity available to all members and attenders of the Yearly Meeting related to our sexual offender policy and make a list of resources available.

Overview

Provide focus and coordinate efforts on environmental work in the Southeastern Yearly Meeting (SEYM) region.

This reports is a summary of activities undertaken since the 2025 SEYM Annual Gathering. It also includes plans for upcoming activities including in-person, hybrid, and remote visits. These plans will include focus on:

- *Community preparedness as we enter the 2025 hurricane season;*
- *Work with Quaker Earthcare Witness, United Nations Working Group; and*
- *The intersection of the U.S. political environment and Earthcare.*

Communication with the FSE Anchoring Committee

I continue to communicate with the FSE Anchoring Committee members email, telephone, or other remote means. While there have been no in real life (IRL) since Gathering, I anticipate visiting Tallahassee Monthly Meeting prior to Fall Interim Business Meeting to meet with Phoebe and Neil Andersen. This visit will include field secretary activities and instruction on the Yearly Meeting archives. This instruction is related to the research in response the call from the National Native American Boarding School Healing Coalition and the Decolonizing Quakers Working Group. I also anticipate meeting IRL with Bill Carlie, Yearly Meeting Clerk, as plans develop for another Cosmic Mass in the St. Petersburg area.

Meeting with Monthly Meetings (MMs), Worship Groups (WGs), and Others

Perform visits to Monthly Meetings and Worship Groups within SEYM to help them discern their leadings in care of the Earth, and to provide information and coordination among Meetings.

I continue to address community preparedness concerns. While weather and climate are prioritized at this time of the year, the political environment also give rise to public health concerns in a number of areas—viruses, immigration, migration, the economy...I am putting the suggestions that SEYM Friends suggested last year's hurricane season together with the Grow Permaculture Hurricane Preparedness Guide, <https://growpermaculture.com/hurricane-preparations/>. This compilation will be available as a separate document, emailed to Monthly Meetings and Worship Groups, and made available on the SEYM website.

Deland Monthly Meeting, 14 and 22 Sixth Month (June)

On 14 Sixth Month, the City of Deland will observe Juneteenth. I will join the Deland Quaker Meeting in their planned banned book giveaway at the Sanborn Center, Earl Brown Park, between 10:00 a.m. and 4:00 p.m.

I will return to Deland on 22 Sixth Month to facilitate a Bystander Intervention Training workshop. As suggested earlier, the social and climatic environments are bringing together a number of concerns. This workshop is intended to help Friends and others identify and practice nonviolent responses to "...public instances of racist, anti-Black, anti-Muslim, anti-Trans, and other forms of oppressive interpersonal violence and harassment while considering the safety of all parties." The workshop will take place after the rise of Meeting on Firstday, 22 Sixth Month.

Planned Visits

Future visits include, but not scheduled as yet,

- AVP workshop(s) in St. Petersburg;
- Quakers of Orlando either/and "Conversations to Explore" and a possible discussion with the Property Committee regarding the grounds;
- An online or hybrid offering of "The Racial Wealth Gap" simulation;
- Visit Tallahassee Monthly Meeting as discussed above;
- Followed by a visit to Gainesville Monthly Meeting to visit the Yearly Meeting archives at University of Florida, and
- As discussed in greater detail below, an online presentation of Power-Mapping Workshop. I will be reaching out to Hope and Larry Ascher, Melbourne Monthly for their help in co-facilitating.

Interactions or Collaborations between and among other SEYM committees


These interactions between and among SEYM committees help to facilitate communication and collaboration of our regional concerns with national organizations and to be a Quaker Presence at specific events.

On 4 Second Month 2025, the Administration issued Executive Order 14199—Withdrawing the United States From and Ending Funding to Certain United Nations Organizations and Reviewing United States Support to All International Organizations.

- QUNO New York staff led a discussion, Introduction to Programme Planning. This included a review its strategic plan and planning process. I was particularly interested in the review of the entry point, United Nations Sustainable Development Goal 16: Promote peaceful and inclusive societies for sustainable development, provide access to justice for all and build effective, accountable and inclusive institutions at all levels. As discussed above, this SDG has been central to the work of the QEW UN Working Group. QUNO staff shared a resource that may be of interest to Friends, "Civil Society at the United Nations", https://quno.org/sites/default/files/timeline/files/Civil%20Society%20at%20the%20United%20Nations_0.pdf. The paper discusses the loss of civic space at the UN and "...provides analysis and recommendations for meaningfully including civil society across the UN's policy agenda in New York, based on the existing negotiated resolutions and established best practice.";
 - The committee was unable to complete all the items on the agenda and will reconvene on 2025.06.10.
- Tri-City NAACP Branch: I continue with the Environmental and Climate Justice Committee.
- University of South Florida: This summer I am doing research with the Weather, Climate, and Society, National Science Foundation research experience for undergraduates. While students will select individual topics, much of our research will focus on the impacts of the 2024 hurricane season in Florida.

- In her Director's report, Sarah Clarke, QUNO New York, shared information about the "Changing UN landscape." This year during what is usually a routine vote on the recognition of the International Day of Peaceful Coexistence, the USA was one of only three countries to vote against the resolution. Edward Heartney, a Trump administration representative said, in reference to the reaffirmation of the 2030 Agenda for Sustainable Development contained in the resolution, that the 2030 agenda and sustainable development goals "advance a program of soft global governance that is inconsistent with US sovereignty and adverse to the rights and interests of Americans." Heartney's letter, dated 2025.03.04, which contain his comments can be found here, <https://usun.usmission.gov/remarks-at-the-un-meeting-entitled-58th-plenary-meeting-of-the-general-assembly/>. (The US announced, in another letter of the same date, it was withdrawing from the board of a UN-backed climate damage fund designed to provide financial assistance to nations most

2025 Summer Executive Committee Meeting

21 Sixth Month 2025

The SEYM Worship and Ministry Committee continues to seek way forward in Spirit to bring needed spiritual nurture to all in the SEYM community and beyond. We are paying special attention in our work to the most vulnerable among us, looking at ways we can support those who are being targeted in our community and in our world. The Yearly Meeting Gathering was an uplifting experience; many participants expressed their appreciation for the daily Worship Sharing as well as the opportunities for spiritual enrichment in workshops led by Worship and Ministry members. Extended Worship was not very well-attended, and we attribute that to the plethora of other opportunities available at the same time. We hope next year to be able to schedule this at a more convenient time. We were also disappointed that there was no space in the schedule for a Memorial Meeting. The committee brought forward some ways to keep in our hearts and minds Friends who have gone before us as well as other milestones being celebrated by our Meetings and Worship Groups.

The online participation in Yearly Meeting Gathering was better this year, with improved technical setup. The online Worship Sharing group grew larger each day and community developed among the participants. Those online expressed their desire for even more opportunities for Friends not in person to be able to participate more fully in Gathering events. A group, led by new Worship and Ministry committee member, Hope Ascher, met to discuss ways that they could support the Gathering Committee in making this a reality with the awareness of not creating extra work for them.

We are happy to announce an upcoming workshop on 19 Seventh Month presented by Dwight Dunstan. His topic will be *The Right Time to Change: Growing Our Hearts to Meet the Moment*. Watch the SEYM website and eNews for details and registration. We invite Friends from all over to join us for this timely and engaging topic for our present circumstances.

The Worship and Ministry Committee recognizes the need for support and encouragement of Meetings and Worship Groups with diminishing numbers. We are providing links on the SEYM website to a document written by Emily Provance on this topic as well as other information that might be useful to any finding themselves in this position. A piece of wisdom that arose from the committee's discernment was to keep Friends from rushing to the conclusion that their Meeting should be laid down. These things often run in cycles and we recognize that "we are what the world is looking for" so we can hold onto that and see what other solutions arise before giving up.

As an extension of the pastoral care provided by Worship and Ministry, we received a request to bring forward to Executive Committee consideration of funding and technical assistance for the acquisition of Bluetooth hearing assistive technology for use at Gathering, EC, and IBM. It would greatly improve the experience for Friends with hearing loss.

Overall, the Worship and Ministry Committee continues to seek ways to help Friends to "be the Light – to go forward in this climate that has so much negativity and violence in action and rhetoric."

Youth Committee Report

2025 Summer Executive Committee Meeting

21 Sixth Month 2025

Attached is the Youth Committee's proposal for an inclusion of an addendum in the CAPP Manual regarding registered sex offenders at SEYM gatherings.

Draft of addendum to SEYM CAPP Manual:

A registered sex offender, after counseling and with no further indictments or convictions, who wishes to join SEYM gatherings where children are present, must have an established relationship with a monthly meeting within SEYM and must be accompanied 24 hours per day by a designated responsible adult from their meeting. They are not allowed in or near the children's program area or when the children are engaged in indoor activities—such as the talent show—or outdoor activities—such as swimming, canoeing, and playing outdoor games. Registered sex offenders are expected to keep a distance from children in all activities, including intergenerational activities and shared spaces.

The Youth Committee, the Youth and Young Adult Program Coordinator, youth volunteers and staff, parents of children attending the SEYM event, and the Registrar must be informed in advance as soon as registration closes that the offender has registered for the SEYM event. Parents and any youth program workers, having been informed of the required precautions, may then decide whether to attend or not.

[Annual Gathering](#)

Thirty-four youth and young adults attended the Annual Gathering this year: 6 young Friends, 7 teenagers, and 21 young adults. Young Friends enjoyed playing together, swimming, and listening to Faith and Play stories. Kayaking, swimming, crafting, and climbing ropes were popular with the teens and young adults. Our four high school graduates each received a copy of SEYM's *Faith and Practice* and a personalized card signed by many Friends in attendance. Several young adults reported feeling encouraged and challenged by the Walton lecturer's workshops.

[Registered Sexual Offender Policy](#)

The YYA Coordinator and one young adult Friend served on an SEYM *ad hoc* committee to create a policy regarding participation by those legally required to register as sexual offenders (RSOs). The committee reached unity on June 3 and will present the policy to the Summer Executive Committee Meeting on June 21, 2025, with a recommendation to add relevant portions to the CAPP manual.

Orlando Monthly Meeting welcomed three new young families with children who have been attending regularly.

[Youth and Young Adult \(YYA\) Activities](#)

Gavin facilitated a conversation about his experience at the Friends World Committee for Consultation (FWCC) conference in March, and Kasper gave a presentation about his School of the Spirit residency program. Asma is on the planning committee for the Friends General Conference YYA Gathering, which several SEYM members will be attending in July. She and other young adults are also active in a Friend's local political campaign. Young adults in Orlando are deeply concerned about the city's housing crisis and have continued to involve themselves in this issue through direct ministry to homeless individuals and through increasing involvement with and outreach to community partners. Gainesville Monthly Meeting's newsletter recently highlighted several young adults who expressed the deep influence of Quakerism on various aspects of their lives, including their artwork and parenting styles. Four teens (Orlando, Melbourne, and Miami) graduated from high school, several attend colleges, and our Youth Committee Clerk, Amanda, continues in law school.

The Youth and Young Adult Program continued to send a periodic newsletter and other reminders via email and made regular posts for its 235 Instagram followers. In response to requests from several young adults, SEYM YYA now also hosts a Discord server where Friends can chat and stay informed about events online and in their communities.
