

SEYM Total Cash Flow not including Trustees

The overall cash flow of the Yearly Meeting (excluding accounts under the care of the Trustees) yielded a net loss (excluding unrealized capital gains) of \$6,515. This resulted from an SEYM total real income of \$189,793 against total expenses of \$196,308.

SEYM General Fund for Administration - Cash Flow and Budget Performance

At the end of the fiscal year, the General Fund (the operations fund for which we approved a balanced budget of \$118,155 in our 2024 Yearly Meeting sessions) showed a net loss of \$10,868. This resulted from General Fund total income of \$104,927 (89% of budget) against expenses of \$115,795 (98% of budget). NOTE: The \$10,868 loss includes transfers into and out of the General Fund of program surpluses and to cover program deficits. Prior to these transfers the General Fund had a loss of \$6,710.

Budget Support Apportionments & Contributions Received

During this fiscal year, in response to the annual request for support of the approved General Fund Budget (the Apportionments), contributions received from the Monthly Meetings and Worship Groups totaled \$81,606, or 78% of the year's budgeted request of \$104,150.

Sixteen (16) Monthly Meetings and four (4) Worship Groups were included in the Apportionment request this fiscal year. 12 contributed between 90% and 100%(+) of their requested amount, 2 contributed 75%, one contributed 50%, and 5 contributed nothing.

The unrestricted individual donations received toward the Budget during this period totaled \$4,470 approximately 112% of the \$4,000 budgeted amount.

Cash Flow Results for Programs

The annual programs for this fiscal year are complete. There may, however, be some adjustments to these figures.

The Yearly Meeting Gathering and Walton Lecture had an income of \$44,304 and expenses of \$47,591, yielding a net deficit of \$3,287, which was covered by the General Fund.

Half Yearly Meeting had an income of \$1,288 with expenses of \$3,528 giving a net deficit of \$2,240, which was covered by the General Fund.

The Michener Lecture had an income of \$2,240 with expenses of \$1,881 giving a net surplus of \$359, which was transferred to the General Fund.

No funds we expended from the International Worship Group Support fund, giving a \$1,200 surplus. The surplus was transferred to the General Fund.

Programs for Youth & the YYAC had income of \$28,361 (of which \$20,000 was from the Trustees Unrestricted investments) with expenses of \$23,326 giving a net surplus of \$5,035.

The Publications program during this period had a net real income of \$1,427, excluding unrealized capital gains of \$577 on investments for the program.

Net Worth

The Net Worth of the combined Yearly Meeting and its Trustees at the end of this period was \$640,660, a decrease of \$318 including \$28,289 in unrealized capital gains since the beginning of the fiscal year.

Worship and Ministry Committee Report SEYM Fall Interim Business Meeting 4 Tenth Month 2025

The SEYM Worship and Ministry Committee continues its ministry of listening to the needs of the Yearly Meeting and following our Guide in providing spiritual nurture and opportunities for Friends in SEYM and beyond.

We had an online presentation on July 19th by Dwight Dunstan, The Right Time to Change: Growing Our Hearts to Meet the Moment. Friends had time to explore spiritual interaction among others as well as individual reflection.

Four weekends in August and September found Friends gathered for a workshop by Shulamith Clearbridge: Bubbling Springs: The Life & Writings of Margaret Fell. We know hearts will be touched deeply by her ministry.

The Worship and Ministry Committee continue to seek new ways for Spirit to work among Friends. We have an intentional concern for all SEYM Friends and hold in prayer the lives and ministries of individuals and Monthly Meetings/Worship Groups. The strife and struggle of the present moment is the same that Quakers have historically risen to meet – the way we make change is by being faithful and the way we are faithful is through listening and responding.

DeLand Quaker Meeting's Minute Regarding the Everglades Migrant Prison SEYM Fall Interim Business Meeting 4 Tenth Month 2025

The DeLand Quaker Meeting deplores the establishment of the Everglades Migrant Prison in the fragile environment of the Everglades. Reliable reports of conditions within the prison, the lack of adequate nutrition and sanitary facilities give us grave concern for the mental and physical health of the detainees. We stand in solidarity with the Miccosukee Tribe of Indians in Florida in calling for the immediate closure of the camp to preserve the air quality, drinking water supply, and the sacred ecological balance vital to the Miccosukee way of life.

We applaud the recent landmark agreement between the state of Florida and the U.S. Department of the Army to accelerate the restoration of the Everglades. We feel the establishment of the Everglades Migrant Prison is completely counterproductive to the restoration project's goals and betrays the promise made to Florida residents and the one million people who visit Everglades National Park each year, generating more than \$120 million dollars of revenue to our state.

There is only one Everglades in all the world. We Floridians are the trustees of this unique, beautiful, and spiritually important wetland. It is incumbent upon our governor and our legislature to reflect that trust, not betray it.

Ad hoc Committee on Organizational Documents Report SEYM Fall Interim Business Meeting

The committee has been meeting regularly, primarily once a week, for two-hour sessions since January 2024. The current Handbook consists of 151 pages, which requires careful consideration and time.

The Handbook was last revised in 2007, and over the past 18 years, there have been several changes in the roles and responsibilities of clerks, committees, and representatives in the process of serving Friends. The Committee members are Neil Andersen, Phoebe Andersen, and Ed Lesnick.

Peace and Social Concerns Committee Report SEYM Fall Interim Business Meeting 4 Tenth Month 2025

Report (prepared by Warren Hoskins, co-clerk) of the Zoom meeting held Saturday August 16, 2025, starting at 11 AM

Present: Warren Hoskins (Tallahassee) the committee co-clerk, Beverly Ward (Tampa Meeting, attends Deland Meeting) who was our Zoom host, Helen Fox (Fort Myers), Shawna (Gainesville), Gail Stallings (Gainesville), John Heimburg (Orlando)

The following Query was read, followed by silent worship:

As a Meeting, are there spiritual tools and practices to help us and others to work with the grief, anxiety, guilt and perhaps anger that arise with all the issues facing us (long covid, wars, climate change, refugees, threats to vulnerable communities and to democracy)? How do we as Quakers face this in a loving, life-affirming way within ourselves as individuals and as a community?

Helen Fox invited us to read, reflect on, and respond to the statement from eight Quaker organizations (the American Friends Service Committee (AFSC), Canadian Friends Service Committee, Friends Committee on National Legislation (FCNL), Friends World Committee on Consultation World Office, Quakers in Britain/ Quaker Peace and Social Witness, Quaker Council on European Affairs, Quaker Service Norway, and the Quaker United Nations Office (QUNO)) entitled: "Quakers discern genocide is occurring in Gaza and urges courageous action". AFSC has posted on its website

Dear Friends,

We invite you to read, reflect on, and respond to Quakers discern genocide is occurring in Gaza and urge courageous action. This vital statement follows extensive discernment within and between our eight global Quaker organizations. In a time of grave concern, we came to unity on the need to witness publicly for an end to violence, including the violence of forced starvation, and the resumption of work to build peace and equality in Palestine and Israel.

We ask Friends to consider endorsing our statement. For many meetings and churches this may be an opportunity to engage with integrity in discerning your understanding of our testimonies and your commitment to witness. We rejoice together in the call to faithfulness, continuing in acts of solidarity until genocide ends and peace prevails.

MINUTE: The SEYM Peace and Social Concerns Committee agrees with and supports the statement by Quaker organizations, "Quakers discern genocide is occurring in Gaza and urge courageous action" and will seek to endorse it as a committee and wishes to start the process of discernment by the Yearly Meeting and SEYM's monthly meetings to carry out endorsement as soon as possible. The SEYM Peace and Social Concerns Committee requests that the Statement with the AFSC links and resources be published in the SEYM newsletter for discernment of endorsement by meetings and SEYM.

11:38 AM: Discussion on recommendation of funds for AFSC to be designated from funds coming to SEYM – Shawna spoke to the expected contribution to SEYM coming from the estate of Georgia Guin. Members of our committee have been discussing this before this meeting, and united on our recommendations:

MINUTE: The Peace and Social Concerns Committee recommends that once the Georgia Guin funds are given to SEYM, an immediate contribution of \$25,000 be made to the Miami AFSC office of the American Friends Service Committee, designated for supporting their South Florida work with immigrants. Approved 11:45 AM

The following pages are a summary of the meeting generated by Zoom's AI, edited for this report and supplemented with notes by Warren.

Prior to the formal start of the committee meeting, the following were discussed:

ARRC Convocation and Organizational Challenges

Beverly and Warren discussed the August 14, 2025, Alliance for Resilient and Regenerative Communities (ARRC) Convocation, a monthly remote meeting Beverly had been unable to attend this month. Warren, who is on the board of Sustainable Tallahassee and on the Natural Resources Committee of the League of Women Voters of Tallahassee, expressed interest in sharing information about the convocation with these groups.

They also talked about organizational structures, mentioning superhydras and the challenges of living up to Quaker principles without resorting to hierarchical leadership models. The conversation touched on moral injury, particularly in the context of U.S. military actions and tax dollars funding weapons, and both expressed frustration with taxation without representation in Florida.

Environmental Insights and Personal Journeys

Warren shared insights from the book "Common Shock" by Kaethe Weingarten, a book about witnessing violence and its effects, which complements discussions on moral injury and nonviolent activism. Warren expressed a desire to introduce Friends to Weingarten's work, highlighting its relevance to current times. The conversation shifted to personal experiences, with Helen and Beverly discussing their environmental interests and travels, including visits to the Everglades and local nature preserves. They also shared experiences of living in different regions of the United States and their efforts to learn about and engage with their environments.

Social Justice and Spiritual Reflection

The meeting began with introductions and a discussion about attendance, followed by silent worship with a query about spiritual tools to address grief and anxiety related to social issues. Helen shared her personal experiences with loss and current concerns about immigration and Gaza. Warren outlined the agenda, which included topics on concentration camps in Florida, immigrant actions, and a request for funds for SEYM. Helen brought to us the AFSC statement about Gaza that her monthly meeting, Fort Myers, had signed onto. Beverly shared the statement on screen. Warren read to the committee from the statement.

Gaza Statement Endorsement Discussion

The Peace and Social Concerns Committee discussed endorsing this statement on Gaza, which was previously endorsed by 8 major Quaker organizations. The committee agreed to write a minute requesting that the statement be published in the SEYM newsletter for consideration by other meetings. Gail was tasked with reviewing the lengthy statement, while the committee planned to spread awareness about the issue and encourage wider Quaker endorsement.

The statement on the situation in Gaza accuses Israel of genocide and calls for a ceasefire, accountability, and humanitarian relief. Warren proposed text for a minute for the committee to agree with in support the Quaker organizations' statement, urging meetings and the yearly meeting to endorse it. The group discussed the process of sharing the statement with meetings and the executive committee, with Shawna emphasizing the need for action beyond just endorsing. Beverly provided guidance on how to send the statement to meetings, and the group agreed to support the statement while acknowledging the complexity of the situation.

Supporting Immigrant Work in Miami

The Peace and Social Concerns Committee recommended an immediate \$25,000 contribution to the Miami AFSC office to support their South Florida immigrant work, using funds from the Guin donation that SEYM is receiving. The committee discussed the history of AFSC's Miami immigrant office. Warren prepared a draft text for the Minute, and this was discussed and approved. We agreed to send the minutes to SEYM, to the Yearly Meeting Clerk (Liz Dykes), and other relevant parties including the treasurer. Warren noted that while AFSC sometimes prefers centralizing donations, they would attempt to send the funds directly to the Miami office.

Florida Concentration Camp Protests Update

Warren shared updates on recent protests against concentration camps in Florida, including a "Camp Cruelty" street theater and protest demonstration in Gainesville. There is now a proposed facility at Camp Blanding. Gail provided additional details about a "deportation depot" being

planned near Lake City rather than the Camp Blanding site. The capacity of this former prison would be 2,000 people.

Warren wished there could be a dedicated website to monitor Florida's concentration camps and deportation facilities. Gail said she thought that Indivisible Florida's SWIFT task force is coordinating efforts statewide that might include such information. (SWIFT is the State-wide Indivisible Florida Taskforce.) Indivisible now has groups in many areas of Florida.

Helen reported on increased ICE activity in Immokalee, where over 140 people were recently detained, including workers stopped for having tinted windows (like a pretext for a stop to check everyone for papers). The Florida Department of Agriculture is now involved in this. People must watch for unmarked vehicles that they identify as one of these "snatch-and-grab" units.

Food insecurity is getting worse in Immokalee and kids are terrified. People won't come out of their houses. The Fort Myers meeting will be discussing two main initiatives: a \$1,000 donation request to support families affected by incarceration and deportation in Immokalee, and a separate \$1,000 donation to World Central Kitchen for their Gaza food distribution efforts.

Helen spoke about a van being stopped for tinted windows and everyone inside being seized. Fort Myers Friends Peace and Social Concerns Committee is thinking of asking their meeting for a contribution to whatever organization will be supporting the family members of detained/deported people. She also spoke about asking for a meeting contribution to World Central Kitchen to support their work in Gaza.

Gail reported on Gainesville's activities, including protests and support for immigrant justice. Gail said in Gainesville there is an Interfaith Alliance for Immigrant Justice that Quakers participate in. They participate in other protests and actions with Indivisible.

Warren shared information about environmental concerns and upcoming events, including a 3rd Act rally on "Sun Day," Sunday September 21, 2025.

The group agreed to put peace and environmental issues on the Agenda for their next meeting on September 13, 2025.

COVID-19 Impact and Public Health

The meeting then focused on several key topics, including the ongoing impact of the COVID-19 pandemic, public health concerns, and vaccine availability. Warren shared insights on the pandemic's persistence, airborne variants of the SARS virus which continue to be brought into the air everywhere by travelers, and emerging trends of impacts of infection and reinfection, like developmental delays in children born to mothers with COVID infections. The group discussed the need for increased public health awareness and the importance of vaccines like Novavax, which Warren and others found effective but is no longer being promoted. Gail highlighted recent COVID exposures in Gainesville, emphasizing the need for local health monitoring.

The conversation ended with plans for the next Zoom meeting on September 13th, where we will address these issues further and consider actions such as advocating for free testing and supporting healthcare professionals.

As we close our meeting let us contemplate on a larger scale what is happening in the world: the wars and campaigns of nations that inflict death, destruction and injury as a matter of policy.

Let us be tender for the suffering of millions around the globe.

Quakers discern genocide is occurring in Gaza and urge courageous action

Jul 28, 2025

We are for justice and mercy and truth and peace and true freedom.

— Edward Burrough, 1659

As Quakers, we recognize the divine imprint in every human being and confess the equality of all to live safely and without fear.

We are also compelled as Quakers to speak truth with integrity, including where it is uncomfortable, yet always to do so in love. This requires us to speak against the catastrophic violence in Gaza.

Friends have a long history of working for peaceful coexistence and justice for all people in the Middle East. We have witnessed times when Jews, Muslims, and Christians have enjoyed peace and cooperation in the region. Since the creation of the state of Israel, our organizations have supported nonviolent efforts among both Palestinians and Israelis to protect human rights, prevent violence, address the root causes of conflict, and promote peacebuilding. We still believe a peaceful future for all peoples is possible.

However, through our decades of humanitarian work and accompaniment with Palestinian and Israeli communities we have witnessed the relentless erosion of justice. This lack of justice and the current violence is rooted in the systemic and violent dispossession of Palestinians from their lands and decades of occupation, apartheid policies, and the systematic denial of Palestinian rights.

This history contextualizes the atrocities that are being perpetrated against Palestinians in Gaza and the West Bank today by Israel's military and government – the starvation campaigns, mass killings, mass deportations, ethnic cleansing, settler violence, and calculated erasure of life. These are not isolated horrors, but the brutal continuation of a 76- year project of displacement and denial of Palestinians' human rights.

These decades of dispossession, oppression, occupation, and violence are the backdrop to the cycles of violence in the region including the attacks, killings, abductions, and trauma suffered by Israelis on October 7, 2023.

After deep communal and prayerful discernment, informed by our direct witness in Palestine/Israel and our readings of the positions of international human rights organizations, international and Israeli genocide scholars, and experts on the UN Genocide Convention (1948), we are exercising our religious conviction to speak the truth as we see it. We believe with moral clarity, and in line with the definition of the crime of genocide, that the current actions in Gaza perpetrated by the Israeli government, constitute genocide.

Our peace and equality testimonies are clear: Apparent security for some, bought with the insecurity of others, tears at our shared humanity and cannot bring peace. Peace built on systematic oppression is a lie. We name what we see as genocide after deep discernment – not to incite, but to open eyes, minds, and hearts. We name this painful truth with the fervent hope that the violence it describes will cease, and with continued commitment to help heal the wounds of war on all sides.

Since the 7th of October 2023, we have witnessed the following realities:

- Approximately 1,200 Israelis killed, including over 800 civilians, 36 of them children, over 3,300 injured and 223 people abducted on October 7, 2023.
- Over 57,000 Palestinians directly killed in Gaza, with estimates of the number of people killed as a result of both the direct and indirect impacts of war rising as high as 300,000.
- In Gaza, at least 17,000 children killed, more than 35,000 injured, over 50,000 children lost at least one of their parents. Between 3,000 and 4,000 children in Gaza have had one or more limbs amputated the highest figure for child amputees globally.
- Nearly 10,000 Palestinians held in Israeli military detention, over 3,500 of them without any
 charge or trial, and in facilities where they are regularly subject to violence, sexual abuse,
 torture, and killing.
- Over 200 Palestinian journalists killed.
- Deliberate mass starvation through the systematic obstruction of food, water, and medicine. which has claimed many lives.
- The destruction of over 70% of homes.
- Over 1,450 recorded attacks on health workers, patients, hospitals, and medical infrastructure with at least 1,500 health care workers killed and over 85% of hospitals bombed or besieged. Remaining facilities are systematically denied fuel and electricity cutting power to incubators, dialysis machines, and operating theaters, directly causing preventable deaths.
- Forced displacement of 1.9 million people amid calls to erase Gaza and for the ethnic cleansing of the population.
- State-sanctioned dehumanization and incitement by officials with Palestinians called "human animals" and with politicians, media, and soldiers celebrating killings of civilians.

Article II of the UN Genocide Convention defines genocide as acts committed "with intent to destroy, in whole or in part, a national, ethnical, racial or religious group". We believe the Israeli actions in Gaza meet this threshold.

We cry out equally for the protection of free speech and the right to protest. The moral urgency of this moment demands space for dissent. Across the world, those calling for a free Palestine, an end to genocide, and compliance with international law face censorship, smear campaigns, and legislative criminalization and repression. This silencing – often falsely equating support for

Palestinian rights and/or anti-Zionism with antisemitism – undermines integrity and is a betrayal of democracy and a tool of genocide denial. Quakers know well that speaking truth to power requires the freedom to dissent. This is reflected in the growing numbers of conscientious objectors who take the moral stand and refuse to participate in the atrocities through military service. We reaffirm our belief in the human dignity of all people and our opposition to all forms of discrimination.

All states have a legal duty under the Genocide Convention to prevent genocide. We call for:

- **1.** An immediate, permanent cease re and full humanitarian access
- All parties must recommit to diplomacy and dialogue in order to reach a permanent ceasefire, ending all hostilities.
- Israel must open border crossings for unrestricted aid.
- The international community must fully fund UNRWA and other involved UN agencies.
- **2.** The application of robust, targeted, and timebound sanctions, including a comprehensive arms embargo, aimed at ending Israel's genocide in Gaza and the related system of apartheid.
- Diplomatic: Use all diplomatic channels to exert pressure, including by denying visas to officials inciting or justifying genocide/apartheid.
- Economic: Suspend trade agreements and ban settlement goods devastating Palestinian livelihoods.
- Financial: Freeze assets of officials and settler militias; block transactions funding oppression.
- Military: Halt all arms sales, transfers, and military cooperation with Israel
- Transport: Block cargo sustaining genocide or apartheid.
- **3.** Respect for international law and accountability
 - The international community must hold Israel accountable to International Law and support the order of the International Court of Justice (ICJ) seeking provisional measures to prevent further harm, and remove any obstacles to support the International Criminal Court (ICC) investigations and rulings into war crimes and crimes against humanity, including apartheid.
 - Demand transparent government reports on compliance with legal duties to prevent genocide and apartheid.
- **4.** Protection of free speech and the right to protest
 - Legislatures must reject all institutional efforts to criminalize solidarity with Palestine.
 - Authorities must safeguard students, academics, workers, and activists from censorship, cyber harassment, or retaliation for advocating Palestinian rights, while ensuring public spaces remain open for peaceful assemblies demanding cease re and justice.
 - Media outlets must center Palestinian voices, commit to facts without bias, and amplify independent journalism documenting Gaza's reality.
 - **5.** Dismantling of oppression and establishing a just and permanent peace
 - End the occupation and apartheid policies across Palestine.
 - Uphold Palestinian self-determination and refugees' right of return.
 - Ensure equal rights, dignity, and security for Palestinians and Israelis and challenge efforts to silence them – rejecting any system privileging one group over another.

As Quaker signatories, we commit to:

- Advocate relentlessly for the end of the Israeli genocide in Gaza and the deliberate starvation campaign, a permanent cease re and accountability for atrocities committed in Gaza, the West Bank and East Jerusalem.
- Boycott settlement goods and divest from companies profiting from occupation, apartheid, or genocide (e.g., arms manufacturers, settlement financiers).
- Reach out in love to Jewish, Muslim and Palestinian communities, confronting antisemitism, anti-Muslim and anti-Palestinian hate while refusing to be silent in the face of oppression.
- Highlight the voices of Palestinians, which have still been all-too- absent from media narratives.
- Support humanitarian relief for Gaza and communities suffering under occupation in the West Bank.
- Advocate for the universal human rights of all people in Palestine and Israel— ensuring they can live in freedom and dignity, without fear, and with lasting peace and security.

We hold in the Light all suffering peoples and leaders, praying they choose justice. In Palestine and Israel, peace built on equality is the only path forward.
